Section 4 of the Principal Act is amended in subsection (3) (b) Amendment of Section 4 5 by substituting the words "on the recommendation of the Minister" for the 6 words "subject to the confirmation of the Senate in consultation with the 7 House of Representatives". 8 3. Section 7 of the Principal Act is amended by deleting subsection Amendment of Section 7 9 (5). 10 4. Section 8 of the Principal Act is amended-Amendment of Section 8 11 (a) in subsection (1) (a), by substituting for the words "on the 12 recommendation of the Minister" for the words "subject to the confirmation 13 of the Senate, in consultation with the House of Representatives"; and 14 (b) in subsection (3) (a) by inserting after the word "Act" in line 4, 15 the words "in accordance with the principle of Federal Character". 16 5. Section 9 of the Principal Act is amended by inserting new Amendment of Section 9 sections "9A", "9B", "9C" "9 A (1) The Board shall not later than so" 17 18 September in each year, submit to the National Assembly through the 19 President, an estimate of the expenditure and income of the Fund during the 20 next succeeding year for approval.
