	8	Science and Technology;
	9	(f) one person to represent the Committee of Heads of Federal
	10	Colleges of Agriculture (NAHCARD);
	11	(g) one person to represent the State Colleges of Agriculture;
	12	(h) one person to represent the Industrial Training Fund (ITF);
	13	(i) two persons to be appointed on individual merit, on a nationwide
	14	basis, who should have wide experience on services in the public or private
	15	sector; and
	16	(j) The Executive Secretary of the Commission who shall be the
	17	Secretary of the Governing Board.
	18	(2) Members of the Board, other than those appointed under
	19	paragraphs (a), (b), (c) and (d) of Subsection (1) of this section, shall be
	20	appointed by the President on the recommendation of the Minister.

	22	member of the Commission, not being a public officer under paragraph (a)-(d)

10	(b) to make recommendations on the national policy necessary for	
11	the full development of agricultural education and the training of	
12	agricultural technicians and technologists;	
13	(c) to set minimum standards for all programmes of colleges of	
14	agriculture and accredit their certificates and other academic awards after	-
15	obtaining prior approval of the Minister;	
16	(d) to determine, after consultation with the National Manpower	
17	Board, the Industrial Training Fund and such other bodies, as it may	•
18	consider appropriate, the technical manpower needs of the country in the	
19	industrial, commercial and other relevant fields for the purpose of planning	
20	for training facilities and, in particular, to prepare periodic master plans for	
21	the balanced and coordinated development of Colleges of Agriculture in	
22	Nigeria.	
23	Such plans shall include:	
24	(i) the general progress to be pursued by Colleges of Agriculture to)
25	maximize the use of available facilities and avoid unnecessary duplication	
26	while ensuring that they are adequate to the manpower needs of the country	7,
27	and	
28	(ii) recommendation, to the Minister, for the establishment and	
29	location of new Colleges of Agriculture, as and, when it is considere	d
30	necessary:	

Supplementary functions of the Commission

Ţ	(e) to inquire into and advise the Federal Government on the financial
2	needs, both recurrent and capital, of Colleges of Agriculture to enable them
3	meet the objective of producing the trained manpower needs of the country;
4	(f) to receive block grants from the Federal Government and allocate
5	them to Colleges of Agriculture in accordance with such formula as may be laid
- 6	down by the Federal Executive Council;
7	(g) to act as the agency for channelling all external aid to Colleges of
8	Agriculture in Nigeria;
9	(h) to advise on, the steps to harmonize entry requirements and
10	duration of courses at Colleges of Agriculture and other similar institutions;
11	(i) to lay down standards to be attained and continually review such
12	standards;
13	(j) to develop and review curricula of Colleges of Agriculture and
14	Related institutions;
15	(k) to collate, analyse and publish any information relating to
16	agricultural education in Nigeria;
17	(l) to review methods of assessment of students and trainees and
18	develop a scheme of national certification for the various products of colleges
19	of agriculture;
20	(m) to undertake periodic review of the terms and conditions of
21	service of personnel in Colleges of Agriculture and make recommendations
22	thereon, through the Minister, to the Federal Government;
23	(n) to recommend to the visitor of a College of Agriculture that a
24	visitation be made to the College as and when it considers it necessary;
25	(o) to consider any matter pertaining to Agricultural education as may
26	be referred to it from time to time by the Minster; and
27	(p) to carry out such other activities as are conducive to the discharge
28	of its functions under this Bill.
29	6. In its role of advising on all aspects of agricultural education, the
30	Commission shall make recommendation as to how best to:

Ţ	(1) summate and encourage interest and appreciation of agriculture	
2	as a business;	
3	(ii) advise on and take measures to improve the immediate and	
4	long-term prospects of agriculture and agricultural teachers with respect to	
5	status and remunerations;	
6	(iii) expand the facilities for the training of agricultural teachers	
7	and ensure that these teachers are exposed, both during and after training, to	
8	practical experience;	
9	(iv) involve experts both in government and industry, in the design	
10	of courses relevant for practical and pre-vocational needs of the country; and	
11	(v) provide encouragement for women and youths to enter a wide	
12	range of pre-vocational and entrepreneurial courses in agricultural	
13	education.	
14	7(1) There shall be appointed by the President, on the Executive	
15	recommendation of the Minister, an Executive Secretary to the Commission	
16	Commission, who shall have appropriate qualification and experience in	
17	agricultural education.	
.18	(2) The Executive Secretary shall be the Chief Executive Officer of	
19	the Commission and shall be responsible for the execution of the policies of	
20	the Commission and the day-to-day running of the affairs of the	
21	Commission.	
22	(3) The Executive Secretary shall hold office for a period of five	
23	years and shall be eligible for reappointment for another term of five years	
24	and no more.	
25	(4) Subject to this section, the Executive Secretary shall hold office	
26	on such terms as to emolument and otherwise, as may be specified in his	
27	letter of appointment, as may be approved by the President.	
28	8(1) The Commission may appoint other employees of the Staff of the Commission

·	13	terms which preclude the grant of a pension and gratuity in respect of that

	15	(3) For the purposes of the application of the Pensions Act, any power
	16	exercisable thereunder by the Minister or authority of the Federal Government
	17	(not being the power to make regulations under section 23 thereof) is hereby
	18	vested in and shall be exercisable by the Commission and not any other person
	19	or authority.
	20	(4) Subject to sub-section (2) of this section, the Pensions Act shall in
	21	its application by virtues of the sub-section (3) of this section to any office,

8	the Minister of Finance, and without prejudice to the generality of the power

11	(a) specifying the manner in which the assets of the fund are to be	
12	held, and regulating the making of payments into and out of the fund;	
13	(b) requiring the keeping of the proper accounts and records, for	
14	the purpose of the fund, in such form as may be specified in the rules;	
15	(c) requiring copies of the accounts to be audited periodically by	
16	the Auditor-General of the Federation; and	
17	(d) requiring copies of the accounts and of the auditor's report on	
18	them to be furnished to the President, through the Minister.

	3	allowances and pensions, superannuating allowances and pensions,

	5	of the Commission, so however that no payment of any kind under this
	6	paragraph shall be made to any person who is in receipt of emoluments from
	7	the Government of the Federation or the State;
	8	(c) for the maintenance of any property vested in the Commission;

	10	(d) for, an in connection with, any of its functions under this Act.
Annual Estimates and Accounts	11	13(1) The Commission shall submit to the Minister not later than 30
and Accounts	12	September in each year, an estimate of its income and expenditure during the
	13	next succeeding financial year.
	14	(2) The Board shall keep proper accounts in respect of each year (and
	15	proper record in relation thereto) and shall cause the account to be audited by an
	16	auditor appointed from the list and in accordance with the guidelines supplied
	17	by the Auditor-General for the Federation.
Annual Reports and Audit	18	14. The Board shall prepare and submit to the President through the
	19	Minister, not later than 30 June in each year, a report in such form as he may
	20	direct on the activities of the Commission, on or during the immediate
	21	preceding year, and shall include in such report a copy of the audited accounts
	22	of the Commission for the year and the Auditor-General's report thereon.
Power to obtain nformation	23	15(1) For the purposes of carrying out the functions conferred on the
	24	Commission under this Bill, the Executive Secretary or any other officer
	25	authorised in that behalf:

1	(2) It shall be the duty of any person required to furnish information	
2	pursuant to sub-section (1) of this section, to comply with the notice within a	
3	reasonable period of time.	
4	(3) In this section, the reference to an institution to which this	
5	section applies, is a reference to any College of Agriculture, College of Land	
6	Resources, Co-operative College or similar institutions.	
7	16. Subject to the provisions of this Act, the Minister may give to	Power of Ministe to give directives

20	"Minister" means the Minister charged with responsibility for Agriculture.

24	FIRST SCHEDULE	-
25	SUPPLEMENTARY PROVISION RELATING TO THE BOARD, ETC,	
26	Proceedings	
27	Cap.92 LFN.	
28	1. Subject to this Act and Section 26 of the Interpretation Act	
29	(which provides for decisions of a statutory body to be taken by the majority	
30	of its members and the Chairman to have a second or casting vote), the	

1	Governing Board may make standing orders regulating the proceeding of the
2	Commission or any committee thereof.
3.	2. Every meeting of the Governing Board shall be presided over by
4	the Chairman and if the Chairman is unable to attend a particular meeting, the
5.	members present at the meeting shall elect one of their members to preside at
6	the meeting.
7	3. The quorum at a meeting of the Governing Board shall consist of
8	the Chairman (or, in an appropriate case, the person presiding at the meeting
9	pursuant to paragraph 2 above) and six other members.
10	4. Where upon any special occasion the Governing Board desires to
11	obtain the advice of any person on any particular matter, the Commission may
12	co-opt that person to be a member for as many meetings as may be necessary,
13	and that person while so co-opted shall have all the rights and privileges of a
14	member except that he shall not be entitled to vote.
15	Committees
16	5(1) Subject to its standing orders, the Commission may appoint
17	such number of Standing and Ad-hoc Committees as it thinks fit to consider
18,	and report on any matter with which the Commission is concerned.
19	(2) Every Committee appointed under the foregoing provisions of
20	this paragraph shall be presided over by a member of the Commission and shall
21	be made up of such number of persons, not necessarily members of the
22	Commission, as the Commission may determined in each case.
23	(3) The quorum of any Committee set up by the Commission shall be
24	as may be determined by the Committee.
25	6. Where standing orders made pursuant to paragraph 1 above
26	provided for a committee of the Commission to consist of or co-opt persons
27	who are not members of the Commission, the committee may advice the
28	Commission on any matter referred to it by the Commission.
29	7. The fixing of the seal of the Commission shall be authenticated by

1	the signature of the Chairman or of the Executive Secretary of the
2	Commission.
3	8. Any contract or instrument which is made by a person not being
4	a body corporate, would not be required to be under seal may be made or
5	executed on behalf of the Commission by the Executive Secretary or by any
6	other person generally or specifically authorised to act for the person by the
7	Commission.
8	9. Any document purporting to be a contract, instrument or other
9	document duly signed or sealed on behalf of the Commission shall be
10	received in evidence and, unless the contrary is provided, be presumed
11	without further proof to have been so signed or sealed.
12	10. The validity of any proceedings of the Commission or
13	Committee thereof shall not be affected:
14	(a) By any vacancy in the membership of the Commission or
15	Committee, or
16	(b) By any defect in the appointment of a member of the
17	Commission or Committee.
18	11. Any member of the Commission or a Committee thereof who
19	has a personal interest in any contract or arrangement entered into or
20	proposed to be considered by the Commission or Committee shall forthwith
21	disclose his interest to the Commission or Committee and shall vote on any a
22	question relating to the contract or arrangement.
23	SECOND SCHEDULE
24	1. The institutions to be supervised by National Commission for
25	Colleges of Agriculture are as follows:
26	(1) Federal and State Colleges of Agriculture, Land Resources and
27	Co-operatives;
28	(2) Private Colleges of Agriculture, Land Resources and Co-
29	operatives; and
30	(3) Other institutions offering National Diploma, Higher National

1 Diploma and equivalent/other certificates in agriculture related courses.

EXPLANATORY NOTE

(This note does not form part of the above Act but is intended to explain its purpose)

The Act set up the National Commission for Colleges of Agriculture as a body corporate and charges it with responsibility for advising the Federal Government on all aspects of Technical Education falling outside the universities, polytechnics and colleges of education; including the general development of Colleges of Agriculture, and other related institutions, and the establishment and location of new ones.
