AN ACT TO AMEND THE UNIVERSITY OF BENIN (TRANSITIONAL. PROVISIONS) ACT, CAP. U4 LAWS OF THE FEDERATION OF NIGERIA 2004 TO SPECIFY THE MINIMUM QUALIFICATION OF THE CHAIRMAN OF THE GOVERNING COUNCIL, OWNERSHIP OF INTELLECTUAL PROPERTY AND TO PROVIDE FOR PRE-ACTION NOTICE TO THE UNIVERSITY AUTHORITY; AND FOR RELATED MATTERS

Commencement

ENACTED by the National Assembly of the Federal Republic of Nigeria-

1. The University of Benin (Transitional Provisions) Act, Cap. U4 Amendment of Cap. U4, LFN, Laws of the Federation of Nigeria, 2004 (in this Bill referred to as "the 2004 2 Principal Act") is amended as set out in this Bill. 3 2.
