13 University or by sending it by registered post, electronic mail or any other
14 legally recognized digital form of communication in Nigeria."

EXPLANATORY MEMORANDUM

This Bill seeks to amend the University of Ilorin Act Cap. U7 Laws of the Federation of Nigeria, 2004 to specify the minimum qualification of the Chairman of the Governing Council, ownership of intellectual property and to provide for pre-action notice to the University authority.
