AN ACT TO AMEND THE FEDERAL CAPITAL TERRITORY APPROPRIATION ACT, 2017 IN ORDER TO EXTEND THE IMPLEMENTATION YEAR OF THE FEDERAL CAPITAL TERRITORY APPROPRIATION ACT, 2017 FROM THE 31ST DECEMBER, 2017 TO 31ST MARCH, 2018 OR, UNTIL THE COMING INTO FORCE ON THE 2018 APPROPRIATION ACT, WHICHEVER OCCURS EARLIER AND FOR RELATED MATTERS

BE IT ENACTED by the National Assembly of the Federal Republic of Nigeria as follows:

1           **1.** The Federal Capital Territory Appropriation Act, 2017 is  
2 hereby amended as set out hereunder.

3           “The authorizing and operative clause is hereby amended by the  
4 deleting from the last line thereof the words "31st December, 2017" and  
5 substituting therefore the words "31st March, 2018" or until the coming into

7 earlier”.

8           **2.** This Bill may be cited as the Federal Capital Territory  
9 Appropriation Act, 2017 (Amendment) Bill, 2018.
