# A BILL

## FOR

AN ACT TO ESTABLISH THE FEDERAL POLYTECHNIC, DOGON DAJI, SOKOTO STATE AND TO MAKE COMPREHENSIVE PROVISIONS FOR DUE MANAGEMENT AND ADMINISTRATION; AND FOR RELATED MATTERS

*Sponsored by Hon, Abdulsamad Dasuki*

ENACTED by the National Assembly of the Federal Republic of Nigeria:

1 PART1- ESTABLISHMENT, CONSTITUTION AND FUNCTIONS OF FEDERAL  
2 POLYTECHNIC, DOGON DAJI

3 1.-(1) There is established the Federal Polytechnic, Dogon Daji (in  
4 this Act referred to as "the Polytechnic").

Establishment of Federal Polytechnic Dogon Daji, Sokoto State

5 (2) The Polytechnic:

6 (a) shall be a body corporate with perpetual succession and a  
7 common seal; and

8 (b) may sue or be sued in its corporate name.

9 2. The objects of the Polytechnic shall be to:

Objects of the Polytechnic

10 (a) encourage the advancement of learning and to hold out to all  
11 persons without distinction of race, creed, sex or political conviction the  
12 opportunity of acquiring higher and liberal education;

13 (b) provide technical courses of instruction and other facilities for  
14 the pursuit of learning in all its branches, and to make those facilities  
15 available on proper terms to such persons as are equipped to benefit from  
16 them;

17 (c) encourage and promote scholarship and conduct research in  
18 restricted fields of learning and human endeavour;

19 (d) relate its activities to the social, cultural and economic needs of  
20 the people of Nigeria; and

	1	(e) undertake other activities appropriate for a Polytechnic of the
	2	highest standard.
Membership of the Polytechnic	3	<b>3.</b> -(1) The Polytechnic shall consist of:
	4	(a) Rector;
	5	(d) two Deputy Rectors or such number of Deputy-Rectors as the
	6	council may, from time to time, deem necessary for the proper administration
	7	of the Polytechnic;
	8	(e) a body to be called Congregation;
	9	(f) a body to be called Convocation;
	10	(g) the campuses and colleges of the Polytechnic;
	11	(h) the Departments, schools, institutes and other teaching and
	12	research units of the Polytechnic;
	13	(i) the persons holding the offices constituted by the First Schedule to
	14	this Act other than those mentioned in paragraphs (a) to (c) of this subsection;
	15	(j) all graduates and undergraduates; and
	16	(k) all other persons who are members of the Polytechnic in
	17	accordance with provisions made by Statute in that behalf.
First Schedule	18	(2) The First Schedule to this Act shall have effect with respect to the
	19	Principal Officers of the Polytechnic mentioned therein.
	20	(3) A provision shall be made by a Statute with respect to the
	21	constitution of the following bodies:
	22	(a) the Council;
	23	(b) the Academic Board;
	24	(c) the Congregation; and
	25	(d) the Convocation.
Functions of the Polytechnic	26	<b>4.</b> -(1) For the carrying out of its objects as specified in section 2 of this
	27	Act, the Polytechnic shall have power to:
	28	(a) establish such campuses, departments, institutes, schools, extra-
	29	mural departments and other teaching and research units within the
	30	Polytechnic as may, from time to time, seem necessary or desirable, subject to

- 1 the approval of the National Board for Technical Education (NBTE);
- 2 (b) institute Chief Lecturerships, readerships and associate Chief  
3 Lecturerships, lectureships and other posts and offices and to make  
4 appointments thereto;
- 5 (c) institute and award fellowships, scholarships, exhibitions,  
6 bursaries, medals, prizes and other titles, distinctions, awards and forms of  
7 assistance;
- 8 (d) provide for the residence, discipline and welfare of members of  
9 the Polytechnic;
- 10 (e) hold examinations and award degrees, diplomas, certificates  
11 and other distinctions to persons who have pursued a course of study  
12 approved by the Polytechnic and have satisfied such other requirements as  
13 the Polytechnic may lay down;
- 14 (f) award honorary degrees, fellowships or academic titles;
- 15 (g) demand and receive from any student or any other person  
16 attending the Polytechnic for the purpose of instruction such fees as the  
17 Polytechnic may, from time to time determine, subject to the overall  
18 directives of the appropriate authority;
- 19 (h) subject to section 22 of this Act, to acquire, hold, grant, charge  
20 or otherwise deal with or dispose of movable and immovable property  
21 wherever situate;
- 22 (i) accept gifts, legacies and donations, but without obligation to  
23 accept the same for a particular purpose unless it approves the terms and  
24 conditions attaching thereto;
- 25 (j) enter into contracts, establish trusts, act as trustee, solely or  
26 jointly with any other person, and employ and act through agents;
- 27 (k) erect, provide, equip and maintain libraries, laboratories,  
28 lecture halls, halls of residence, refectories, sports grounds, playing fields  
29 and other buildings or things necessary, suitable or convenient for any of the  
30 objects of the Polytechnic;

1 (l) hold public lectures and undertake printing, publishing and book  
2 selling;

3 (m) subject to any limitation or condition imposed by Statute, to  
4 invest any moneys appertaining to the Polytechnic by law of endorsement,  
5 whether for general or special purposes, and such other moneys as may not be  
6 immediately required for current expenditure, in any investment or security or  
7 in the purchase or improvement of land, with power from time to time to vary  
8 any such investment and to deposit any money for the time being un-invested  
9 with any bank on deposit or current account;

10 (n) borrow, whether on interest or not, and if need be, upon the  
11 security of any or all of the property movable or immovable of the Polytechnic,  
12 such moneys as the Council may, from time to time in its discretion, find  
13 necessary or expedient to borrow or to guarantee any loan, advance or credit  
14 facility;

15 (o) make gifts for any charitable purpose;

16 (p) do anything which it is authorized or required by this Act or by any  
17 other Statute to do; and

18 (q) do all such acts or things, whether or not incidental to the  
19 foregoing powers, as may advance the objects of the Polytechnic.

20 (2) Subject to the provisions of this Act and of the Statutes made there  
21 under and without prejudice to section 9 (2) of this Act, the powers conferred  
22 on the Polytechnic by subsection (1) of this section shall be exercisable on  
23 behalf of the Polytechnic by the Council or by the Academic Board or in any  
24 other manner which may be authorized by this Act.

Rector to take  
precedence  
before other  
members

25 **5.-(1)** The Rector shall in relation to the Polytechnic, take precedence  
26 before all other members of the Polytechnic, and when he is present shall  
27 preside at all meetings of convocation held for conferring degrees and  
28 diplomas.

29 (2) Subject to the provisions of this Act, the Rector shall have general  
30 function, in addition to any other function conferred on him by this Act or

1 otherwise, of directing the activities of the Polytechnic, and shall, to the  
2 exclusion of any other person or authority, be the chief executive and  
3 academic officer of the Polytechnic and ex-officio Chairman of the  
4 Academic Board.

5 **6.**-(1) There shall be a Council for the Polytechnic consisting of:

Establishment  
and membership  
of the Council

6 (a) the Rector;

7 (b) Deputy-Rector (Academics);

8 (c) Deputy -Rectors (Administration);

9 (d) one person from the ministry responsible for education;

10 (e) four persons representing a variety of interest and broadly  
11 representative of the whole Federation to be appointed by the President;

12 (f) four persons appointed by the Academic Board from among its  
13 members;

14 (g) two persons appointed by the Congregation from among its  
15 members; and

16 (h) one person appointed by the Convocation from among its  
17 members. (2) Persons to be appointed to the Council shall be persons of  
18 proven integrity, knowledgeable and familiar with the affairs and tradition  
19 of the Polytechnic.

20 **7.**-(1) Subject to the provisions of this Act relating to the Visitor,  
21 the Council shall be the governing body of the Polytechnic and shall be  
22 charged with the general control and superintendence of the policy, finances  
23 and property of the Polytechnic, including its public relations.

Council and other  
Committees of  
the Polytechnic

24 (2) There shall be a committee of the Council to be known as the  
25 Finance and General Purposes Committee, which shall, subject to the  
26 directions of the Council, exercise control over the property and expenditure  
27 of the Council as the Council may from time to time delegate to it.

28 (3) Provision shall be made by Statute with respect to the  
29 constitution of the Finance and General Purposes Committee.

30 (4) The Council shall ensure that proper accounts of the

1 Polytechnic are kept and the accounts of the Polytechnic are audited annually  
2 by auditors appointed by the Council from the list and in accordance with  
3 guidelines supplied by the Auditor-General for the Federation, and that an  
4 annual report is published by the Polytechnic together with certified copies of  
5 the said accounts as audited.

6 (5) Subject to this Act and the Statutes, the Council and the Finance  
7 and General Purposes Committee may each make rules for the purpose of  
8 exercising any of their respective functions or of regulating their own  
9 procedure.

10 (6) Rules made under subsection (5) of this section by the Finance and  
11 General Purposes Committee shall not come into force unless approved by the  
12 Council, and where any rule so made by the Committee conflicts with any  
13 direction given by the Council (whether before or after the coming into force of  
14 the rules in question), the direction of the Council shall prevail.

15 (7) There shall be paid to the members of the Council, the Finance and  
16 General Purposes Committee and any other Committee set up by the Council,  
17 allowances in respect of travelling and other reasonable expenses, at such rates  
18 as may from time to time be fixed by extant government circulars.

19 (8) The Council shall meet as and when necessary for the performance  
20 of its functions under this Act, and shall meet at least four times every year.

21 (9) If required in writing by five members of the Council, the  
22 Chairman shall within, 28 days after the receipt of such request, call a meeting  
23 of the Council:

24 PROVIDED that if after 28 days of the receipt or delivering to him of  
25 such request, the Chairman fails or neglects to call a meeting, the Registrar  
26 shall, within 14 days thereof, cause a meeting of the Council to be convened for  
27 that purpose and the request shall specify the business to be considered at the  
28 meeting and no business not so specified shall be transacted at that meeting.

29 8.-(1) Subject to section 5 of this Act and subsections (3) and (4) of  
30 this section and to the provisions of this Act relating to the Visitor, it shall be the

1 general function of the Academic Board to organize and control teaching in  
2 the Polytechnic, admission to graduate technical courses and other  
3 admission of students, the discipline of students and to promote research in  
4 the Polytechnic.

5 (2) Without prejudice to the generality of the provisions of  
6 subsection (1) of this section, it shall in particular be the function of the  
7 Academic Board to make provision for the:

8 (a) establishment, organization and control of campuses,  
9 departments, schools, Institutes and other teaching and research units of the  
10 Polytechnic, and the allocation of responsibility for different branches of  
11 learning;

12 (b) organization and control of technical courses of study in the  
13 Polytechnic and of the examinations held in conjunction with those  
14 technical courses, including the appointment of examiners, both internal  
15 and external;

16 (c) award of degrees/diplomas, and such other qualifications as  
17 may be prescribed, in connection with examinations conducted by the  
18 Polytechnic;

19 (d) establishment, organization and control of halls of residence  
20 and similar institutions in the Polytechnic;

21 (e) supervision of the welfare of students in the Polytechnic and the  
22 regulation of their conduct

23 (f) granting of fellowships, scholarships, prizes and similar awards  
24 in so far as the awards are within the control of the Polytechnic; and

25 (g) determination of what description of dress shall be academic  
26 dress for the purposes of the Polytechnic, and regulating the use of academic  
27 dress.

28 (3) The Academic Board shall not establish any new campus,  
29 department, school, institute or other teaching and research units of the  
30 Polytechnic, or any hall of residence or similar institution at the Polytechnic

1 without the approval of the Council.

2 (4) Subject to this Act and the Statutes, the Academic Board may  
3 make regulations for the purpose of exercising any function conferred on it  
4 either by the provisions of this section or for the purpose of providing for any  
5 matter for which provision by regulation is authorized or required by this Act or  
6 by Statute.

7 (5) The Academic Board shall, by regulation, provide that at least one  
8 of the persons appointed as examiners at each final or professional examination  
9 held in conjunction with any course of study in the Polytechnic is not a teacher  
10 at the Polytechnic but is a teacher at the branch of learning to which the course  
11 relates in some other Polytechnic of high repute.

12 (6) Subject to a right of appeal to the Council from a decision of the  
13 Academic Board under this subsection, the Academic Board may deprive any  
14 person of any degree, diploma or other award of the Polytechnic which has  
15 been conferred on him if after due enquiry he is shown to have been guilty of  
16 any dishonorable or scandalous conduct in gaining admission into the  
17 Polytechnic or obtaining that award.

18 PART II - STATUTES OF THE POLYTECHNIC

Statutes of the  
Polytechnic

19 9.-(1) Subject to this Act, the Polytechnic may make Statutes for any  
20 of the following purposes:

21 (a) making provision with respect to the composition and constitution  
22 of any authority of the Polytechnic;

23 (b) specifying and regulating the powers and duties of any authority  
24 of the Polytechnic, and regulating any other matter connected with the  
25 Polytechnic or any of its authorities;

26 (c) regulating the admission of students where it is done by the  
27 Polytechnic, and their discipline and welfare;

28 (d) determining whether any particular matter is to be treated as an  
29 academic or non-academic matter for the purposes of this Act and of any  
30 Statute, regulation or other instrument made there-under; and

1 (e) making provision for other matters for which provision by  
2 Statute is authorized or required by this Act.

3 *Cap. 1123LFN,2004*

4 (2) Subject to section 25 (6) of this Act, the Interpretation Act shall  
5 apply in relation to any Statute made under this section as it applies to a  
6 subsidiary instrument within the meaning of section 27 (1) of that Act.

7 (3) The Statute contained in the Third Schedule to this Act shall be Third Schedule  
8 deemed to have come into force on the commencement of this Act and shall  
9 be deemed to have been made under this section by the Polytechnic.

10 (4) The power to make Statute conferred by this section shall not be  
11 prejudiced or limited in any way by reason of the inclusion or omission of  
12 any matter in or from the Statute contained in the Third Schedule to this Act  
13 or any subsequent Statute.

14 **10.**-(1) The power of the Polytechnic to make Statutes shall be Power to make  
15 exercised in accordance with the provisions of this section. and approve  
Statutes

16 (2) A proposed Statute shall not have the force of law until it has  
17 been approved at a meeting of the:

18 (a) Academic Board, by the votes of not less than two thirds of the  
19 members present and voting; and

20 (b) Council by the votes of not less than two thirds of the members  
21 present and voting;

22 (3) A proposed Statute may originate either in the Academic Board  
23 or Council, and may be approved as required by subsection (2) of this 1  
24 section by both bodies in no particular order.

25 (4) A Statute which:

26 (a) makes provision for or alters the composition or constitution of  
27 the Council, the Academic Board or any other authority of the Polytechnic;

28 (b) provides for the establishment of a new campus or school or for  
29 the amendment or revocation of any Statute whereby a campus or college is

1 established, shall not come into operation unless it has been approved by the  
2 Visitor.

3 *Cap. 1123 LFN, 2004*

4 (5) For the purpose of section 2 (2) of the Interpretation Act, a Statute  
5 shall be treated as being made on the date on which it is approved by the  
6 Council and the Academic Board in accordance with subsection (3) of this  
7 section or in the case of a Statute falling within subsection (4) of this section, on  
8 the date on which it is approved by the President.

Proof of Statute  
in court

9 **11.** A Statute may be proved in any court by the production of a copy  
10 thereof bearing or having affixed to it a certificate signed by the Rector or the  
11 Registrar to the effect that the copy is a true copy of a Statute of that  
12 Polytechnic.

Visitor's decision  
in case of dispute

13 **12.-(1)** In the event of any doubt or dispute arising at any time as to the  
14 meaning of any provision of a Statute, the matter may be referred to the Visitor,  
15 who shall take such advice and make such decision thereon as he deems fit.

16 (2) The decision of the Visitor on any matter referred to him under this  
17 section shall be binding upon the authorities, staff and students of the  
18 Polytechnic and where any question as to the meaning of any provision of a  
19 Statute has been decided by the Visitor under this section, no question as to the  
20 meaning of that provision shall be entertained by any other authority in  
21 Nigeria:

22 Provided that nothing in this subsection shall affect the power of a  
23 court of competent jurisdiction to determine whether any provision of a Statute  
24 is wholly or partly void as being ultra vires or as being inconsistent with the  
25 Constitution.

26 (3) The provisions of this section shall apply in relation to any doubt  
27 or dispute as to whether any matter is, for the purposes of this Act, an academic  
28 or non-academic matter as they apply in relation to any such doubt or dispute as  
29 is mentioned in subsection (1) of this section, and accordingly the reference in  
30 subsection (2) of this section to any question as to the meaning of any provision

1 of the Statute shall include references to any question as to whether any  
2 matter is for the said purposes an academic or non-academic matter.

3 PART III - SUPERVISION AND DISCIPLINE

4 13.-(1) The Minister of Education shall be the Visitor of the Supervision and  
Discipline  
5 Polytechnic.

6 (2) The Visitor shall, as often as the circumstances may require not  
7 being less than once every five years, conduct a visitation of the Polytechnic  
8 or direct that such a visitation be conducted by such persons as the Visitor  
9 may deem fit and in respect of any of the affairs of the Polytechnic.

10 (3) The bodies and persons comprising the Polytechnic Shall:

11 (a) make available to the Visitor, and to any other persons  
12 conducting a visitation in pursuance of this section, such facilities and  
13 assistance as he or they may reasonably require for the purpose of the  
14 visitation; and

15 (b) give effect to any instruction consistent with the provisions of  
16 this Act which may be given by the Visitor in consequence of the visitation.

17 14.-(1) If it appears to the Council that a member (other than the Removal of  
members  
18 Rector) should be removed from office on grounds of misconduct or  
19 inability to perform the functions of his office, the Council shall make a  
20 recommendation to that effect through the Minister to the Federal Executive  
21 Council and if the Federal Executive Council, after making such enquiries  
22 (if any) as may be considered necessary, approves the recommendation it  
23 may direct the removal of the member from office.

24 (2) The Minister shall use his best endeavors to cause a copy of the  
25 instrument embodying a direction under subsection (1) of this section to be  
26 served as soon as reasonably practicable on the person to whom it relates.

27 15.-(1) If it appears to the Council that there are reasons for Grounds and  
procedure for  
removal of  
members  
28 believing that any person employed as a member of the academic,  
29 administrative or professional staff of the Polytechnic, other than the Rector,  
30 should be removed from office or on grounds of misconduct or inability to

1 perform the functions of his office Council shall:

2 (a) give notice of those reasons to the person in question;

3 (b) afford such person an opportunity of making representation in  
4 person on the matter to the Council; and

5 (c) take a decision to terminate or not to terminate the appointment.

6 (2) If the affected staff or any three members of the Council so request  
7 within a period of one month from the date of receipt of the notice of the  
8 Council's decision, the Council shall make arrangements for:

9 (a) a joint committee of the Council and the Academic Board to  
10 review the matter and to report on it to the Council;

11 (b) the person in question to be afforded an opportunity to appear  
12 before and be heard by an investigating committee with respect to the matter;  
13 and if the Council after considering the report of the investigating committee is  
14 satisfied that the person in question should be removed, the Council may so  
15 remove him by an instrument in writing signed on the directions of the Council.

16 (3) The Rector may, in a case of gross misconduct by a member of  
17 staff which in the opinion of the Vice- Rector is prejudicial to the interest of the  
18 Polytechnic, suspend such member and any such suspension shall immediately  
19 be reported to the Council.

20 (4) Any member of staff may be suspended from duty or his  
21 appointment may be terminated by Council for a good cause and, for the  
22 purposes of this subsection, "good cause" means:

23 (a) conviction for any offence which the Council considers to be such  
24 as to render the person concerned unfit for the discharge of the functions of his  
25 office;

26 (b) any physical or mental incapacity which the Council, after  
27 obtaining medical advice, considers to be such as to render the person  
28 concerned unfit to continue to hold office;

29 (c) conduct of a scandalous or disgraceful nature which the Council

1 considers to be such as to render the person concerned unfit to continue to  
2 hold office; or

3 (d) conduct which the Council considers to be such as to constitute  
4 failure or inability of the person concerned to discharge the functions of his  
5 office or to comply with the terms and conditions of his service.

6 (5) Any person suspended under subsection (3) of this section shall  
7 be on half pay and the Council shall, before the expiration of a period of  
8 three months from the date of such suspension, consider the case against that  
9 person and come to a decision as to whether to:

10 (a) continue such person's suspension and if so on what terms  
11 (including the proportion of his emoluments to be paid to him);

12 (b) reinstate such person in which case the Council shall restore his  
13 full emoluments with effect from the date of suspension;

14 (c) terminate the appointment of the person concerned in which  
15 case such a person will not be entitled to the proportion of his emoluments  
16 withheld during the period of suspension; and

17 (d) take such lesser disciplinary action against such person  
18 (including the restoration of such proportion of his emoluments that might  
19 have been withheld) as the Council may determine.

20 (6) Where the Council, pursuant to this section, decides to continue  
21 a person's suspension or decides to take further disciplinary action against  
22 the person, the Council shall, before the expiration of three months from  
23 such decision, come to a final determination in respect of the case  
24 concerning such a person.

25 (7) The person by whom an instrument of removal is signed in  
26 pursuance of subsection (1) of this section shall use his best endeavors to  
27 cause a copy of the instrument to be served as soon as reasonably practicable  
28 on the person to whom it relates.

29 (8) Nothing in this section shall prevent the Council from making  
30 regulations for the discipline of staff and workers of the Polytechnic as may

	1	be appropriate.
Removal of Examiner	2	<b>16.</b> -(1) If, on the recommendation of the Rector, it appears to the
	3	Academic Board that a person appointed as an examiner for any examination
	4	of the Polytechnic ought to be removed from his office or appointment, then,
	5	the Academic Board may, after affording the examiner an opportunity of
	6	making representations in person on the matter, direct the Rector to remove the
	7	examiner by an instrument in writing signed by the Registrar.
	8	(2) Subject to the provisions of any regulation made under section 8
	9	(4) of this Act, the Rector may, on the recommendation of Academic Board,
	10	appoint an appropriate person as examiner in the place of the examiner
	11	removed.
	12	(3) The Registrar shall on signing an instrument of removal under this
	13	section, use his best endeavors to cause a copy of the instrument to be served as
	14	soon as reasonably practicable on the person to whom it relates.
Disciplinary action on students	15	<b>17.</b> -(1) Subject to the provisions of this section, where it appears to
	16	the Rector that any student is guilty of misconduct, the Rector may, without
	17	prejudice to any other disciplinary powers conferred on him by Statute or
	18	regulations, direct that the:
	19	(a) student shall not, during such period as may be specified in the
	20	direction, participate in such activities of the Polytechnic or make use of such
	21	facilities of the Polytechnic as may be so specified;
	22	(b) activities of the student shall, during such period as may be

29 Act and in accordance with the provisions of section 12 of this Act,

17 conventional Polytechnic with restricted programmes and limited and focused  
18 Departments.

*Section 3(2)*

PRINCIPAL OFFICERS OF THE POLYTECHNIC

*The Rector*

1. The Rector shall be appointed by, and hold office at the pleasure of, the President.

*The Rector*

2. The procedure for the appointment and removal of the Rector shall be in accordance with the provision Section 8 of the Federal Polytechnics Act Cap F17 Laws of the Federation of Nigeria, 2004.

3.-(1) There shall be for the Polytechnic, two Deputy Rectors or such number of Deputy Rectors as the Council may, from time to time, deem necessary for the proper administration of the Polytechnic.

(2) The procedure for the appointment and removal of a Deputy Rector shall be in accordance with the provision of Section 9 of the Federal Polytechnics Act Cap F17 Laws of the Federation of Nigeria, 2004.

(3) A Deputy Rector shall:

(a) assist the Rector in the performance of his functions;

(b) act in place of the Rector when the post of the Rector is vacant or if the Rector is, for any reason, absent or unable to perform his functions as Rector; and

(c) perform such other functions as the Rector or the Council may, from time to time, assign to him.

*Office of the Registrar, Bursar and Polytechnic Librarian*

4.-(1) There shall be for the Polytechnic, a Registrar, who shall be the Chief Administrative Officer of the Polytechnic and shall be responsible to the Rector for the day-to-day administration of the Polytechnic except as regards matters for which the Bursar is responsible in accordance with paragraph 6 (2) of this schedule.

(2) The person holding the office of Registrar shall, by virtue of

1 that office, be Secretary to the Council, the Academic Board, Congregation and  
2 Convocation.

3 (3) The Registrar shall hold office for such period and on such terms  
4 and conditions as to emoluments as may be specified in his letter of  
5 appointment.

6 5.-(1) There shall be for the Polytechnic, the following Principal  
7 Officers in addition to the Registrar:

8 (a) the Bursar; and

9 (b) the Polytechnic Librarian.

13 members of Council.

14 (2) The Selection Board, after making such inquiries as it thinks fit,  
15 shall recommend a candidate to the Council for appointment to the vacant  
16 office, and after considering the recommendation of the Board, the Council  
17 may make an appointment to that office.

18 (3) A person appointed to the office of Director of Works or Director  
19 of Health Services shall hold office for such period and on such terms and  
20 conditions as may be specified in his letter of appointment.

21 *Creation of Academic Post*

22 10. Recommendation for the creation of posts other than those  
23 mentioned in paragraph 9 of this Schedule shall be made by the Academic  
24 Board to the Council through the Finance and General Purposes Committee.

25 *Appointment of Academic Staff*

26 11. Subject to this Act and the Statute made under it, the filling of  
27 vacancies in academic posts (including newly created ones) shall be as  
28 prescribed from time to time by Statute.

29 *Appointment of Administrative and Technical Staff*

30 12.-(1) The administrative and technical staff of the Polytechnic,

1 other than those mentioned in paragraph 9 of this Schedule, shall be  
2 appointed by the Council or on its behalf by the Rector or the Registrar in  
3 accordance with any delegation of powers made by the Council in that  
4 behalf.

5 (2) In the case of administrative or technical staff that has close and  
6 important contacts with the academic staff, there shall be Academic Board  
7 participation in the process of selection.
