Section 10 of

ENACTED by the National Assembly of the Federal Republic of Nigeria as follows:

1. Section 10 subsection (1) of the Oaths Act Cap. 01 LFN, 2004 (here in after referred to as 'the Principal Act') is amended by: deleting the words "and any Judge of the Federal High Court" and inserting instead, the words "the Chief Judge and Judges of the Federal High court, the President and Judges of the National Industrial Court, the Chief Judge and Judges of the High Court of the Federal Capital Territory, Abuja, the Chief Judge and Judges of a State High Court, the Grand Kadi and Kadis of the Sharia Court of Appeal of the Federal Capital Territory, Abuja, the President and Judges of the Customary Court of Appeal of the Federal Capital Territory, Abuja, the Grand Kadi and Kadis of the Sharia Court of Appeal of a State, the President and Judges of the Customary Courts of Appeal of a State".

2.-(a) by inserting in the column titled "Persons to take Oath", immediately after the words "Chief Judge and Judges of the Federal High Court" wherever they appear in the column, the following words:

3. This Bill may be cited as the Oaths Act (Amendment) Bill, 2015.

EXPLANATORY MEMORANDUM

The Bill seeks to amend the Oaths Act Cap. 01 Laws of the Federation of Nigeria, 2004; to expressly mention in the Act all superior Courts of records established after the Act came into force in 1963 among list of courts authorized by the Act to administer Oaths or Affirmation; and to provide for matters incidental thereto.
