ENACTED by the National Assembly of the Federal Republic of Nigeria -

11. The Students' Union Activities (Control and Regulation) Act, Cap. S14, LFN 2004 (in this Act referred to as "the Principal Act") is amended as set out in this Act.
2. Subsection (1) of section 1 of the Principal Act is amended by deleting the coma after the word "voluntary" and substituting the phrase "and confined to individual campuses of" with the words "in all".
3. Subsection (2) of section 3 of the Principal Act is amendment by deleting the proviso.
4. Subsection (4) of section 5 of the Principal Act is amended by-
- (a) substituting the phrase "not exceeding N50,000" with the phrase "of N250,000", and
- (b) substituting the phrase "not exceeding five years" with the words "of three years".
5. Section 6 of the Principal Act is deleted.
6. Section 7 of the Principal Act is amended by substituting the head note "Duration of the Act", with a new head note, "Designation of other institutions".
7. This Act may be cited as the Students' Union Activities (Control and Regulation) (Amendment) Bill, 2015.
