Subsection (5) of section 2 of the Principal Act is amended by -</p> <p style="padding-left: 20px;">(a) inserting immediately after the word "re-appointment", the phrase, "for an additional term of three years, and no more"; and</p> <p style="padding-left: 20px;">(b) substituting the "colon" that appears immediately after the word "re-appointment", with a "semi-colon".</p> <p>3. Subsection (5) of section 14 of the Principal Act is amended by -</p> <p style="padding-left: 20px;">(a) substituting the phrase "not exceeding N1,000" immediately after the word "fine" in line 1, with the phrase "of N500,000"; and</p> <p style="padding-left: 20px;">(b) substituting the phrase "not exceeding N20" which appears immediately after the word "fine" line 3, with the phrase "of N100,000".</p> <p>4. EXPLANATORY MEMORANDUM
