AN ACT TO AMEND THE EXAMINATION MAL-PRACTICES ACT, CAP E. 15, LAWS OF THE FEDERATION OF NIGERIA 2004 TO VEST FURTHER JURISDICTION IN OTHER COURTS TO TRY OFFENCES COMMITTED UNDER THE EXAMINATION MAL-PRACTICES ACT, 2016.

ENACTED by the National Assembly of the Federal Republic of Nigeria as follows:

- 1 1. The Examination Mal-Practices Act, Cap E. 15 Laws of the Amendment of
2 Federation of Nigeria, 2004 (herein called "The Principal Act") is hereby CAP. E. 15 LFN,
3 amended as set out hereunder. 2004
- 4 2. Section 14 of the Principal Act is amended by inserting Amendment of
5 immediately after the words "Federal High Court", the following, "High Section 14
6 Court of the Federal Capital Territory (FCT), State High Courts and all the
7 Chief Magistrate Courts".
- 8 3. Section 19 of the Principal Act is amended enlarging the Amendment of
9 interpretation of "Court" to include "High Court of the Federal Capital Section 19
10 Territory (FCT), State High Courts and all the Chief Magistrate Courts".
- 11 4. This Bill may be cited as the Examination Mal-practices Act Short Title
12 (Amendment) Bill, 2016.

EXPLANATORY NOTE

This Bill seeks to amend the Examination Mal-practices Act to allow other Courts in addition to the Federal High Court try Offenders for Examination Mal-practices.
