EXPLANATORY MEMORANDUM

This Bill seeks to amend the National Eye Centre Act Cap. N38 Laws of the Federation of Nigeria, 2004 to empower the Centre to acquire property, review the functions of the Centre and provide for standard procedure of removing members of the Board.
