2	this Bill referred to as "the Principal Act") is amended as set out in this Bill.	
3	2. The Second Schedule part I of the Principal Act is altered by	Alteration of Second Schedule part 1 of the 1999 Constitution
4	deleting the phrases thus:	
5	(a) "Mines and minerals" in item 39 on the list, and transfer same to	
6	part ii of the Second Schedule. The new item 39 of the Exclusive legislative	
7	list shall now read; "Oil fields, oil mining, geological surveys and natural	
8	gas".	
9	(b) "Railways" in item 55 on the list, and transfer same to part ii of	
10	the Second Schedule;	
11	(c) "Public holidays" in item 51 on the list, and transfer same to part	
12	ii of the Second Schedule;	
13	(d) "Stamp duties" in item 58 on the list, and transfer same to part ii	
14	of the Second Schedule.	
15	3. The Second Schedule part ii of the Principal Act is altered by	Alteration of Second Schedule
16	inserting the following items:	part ii of the 1999 Constitution
17	(i) Mines and minerals;	
18	(ii) Railways;	
19	(iii) Public holidays; and	
20	(iv) Stamp duties.	

ĺ	(1) The National Assembly may make laws for the federation or any
2	part thereof relating to Mines and mineral fields of the federation, and
3	implementation of international standards relating thereto.
1	(2) A House of Assembly may make laws relating to mines and
5	mineral deposits, management and regulation of mines and mineral fields
5	within the State.
7	(1) The National Assembly may make laws for the federation or any
8	part thereof with respect to:
9	(a) Construction and maintenance of railway tracks and
10	infrastructures;
11	(b) National railway agencies for the regulation and management of
12	railway operation throughout the federation;
13	(c) Inter-state railway regulation and transportation throughout the
14	federation.
15	(2) A House of Assembly may make laws for the State with respect to:
16	(a) Establishment and maintenance of agencies for railway
17	transportation throughout the State;
18	(b) Regulation of State railway carrier.
19	(1) The National Assembly may make laws for the federation with
20	respect to:
21	Declaration of Public holidays.
22	(2) A House of Assembly may make laws for the purposes of
23	declaring public holidays within the State.
24	(1) The National Assembly may make laws for the federation or any
25	part thereof with respect:
26	(a) Payment of stamp duties by incorporated companies and other
27	activities or business over which the National Assembly has powers to make
28	laws;

subject to federal taxation.
