-	BE IT ENACTED by the National Assembly of the Federal
	Republic of Nigeria as follows:
1	1. The Counterfeit and Fake Drugs and Unwholesome Processed

1	(2) Where an offence under section 1 or 2 of this Act has been
2	committed by a body corporate, every person who at the time of the
3	commission of the offence was a proprietor, director, general manager,
4	secretary or other similar officer, servant or agent of the body corporate (or a

- 10. (1). Any drug, poison or unwholesome processed food product
 seized by a Task Force established by this act shall be forfeited to the Federal
 Government and shall be destroyed by the Agency provided that the agency
 shall have the power to confiscate proceeds of crimes under this Act, pay it into
 a fund to be known as "Victims Compensation Fund" and compensate victims
 of such crimes under this act from the fund.
 - (2) The Agency may with the approval of the Minister make provisions for the effective implementation of the provisions of sub section (1) of this act including the establishment of a victim's compensation fund and the procedure for its operation.
- 4. This bill may be cited as The Counterfeit and Fake Drugs and Unwholesome Processed Foods (Miscellaneous Provisions) Act (Amendment) Bill, 2015.

EXPLANATORY MEMORANDUM

The bill seeks to amend the Counterfeit and Fake Drugs and Unwholesome Processed Foods (Miscellaneous Provisions) Act Cap C34 Laws of the Federation 2004 to increase the penalties for those who produce, import, manufacture or sale of counterfeit, fake and unwholesome processed foods in Nigeria and to provide for the forfeiture of assets and proceeds of crime as well as compensate victims from a such assets.
