INDUSTRY IN NIGERIA AND FOR RELATED MATTERS Sponsored by Hon Umar Jibrin Commencement BE IT ENACTED by the National Assembly of the Federal Republic of Nigeria as follows: PART 1 - ESTABLISHMENT AND OBJECTIVES OF THE NIGERIAN FILM COMMISSION 1.-(1) There is hereby established a body to be known as the Establishment of the Nigerian Film Commission 2 Nigerian Film Commission (in this Act referred to as "the Commission"). (2) The Commission: (a) shall be a body corporate with perpetual succession and a 4 common seal and may sue or be sued in its corporate name; and 6 (b) may acquire, hold or dispose of any property, movable or immovable in its corporate name, for the purpose of carrying out its functions under this Act. (3) objects of the Commission: 10 (a) develop a result oriented productivity communission geared towards profit making and revenue generation that will reduce total dependence on Government subvention; 13 (b) provide and create a framework for a viable susta linable growth 14 and orderly development of a globally competitive Nigerian : film and video 15 industry. 13	(c) establish a National Film, Video & Sound Archive as a
14	mandatory depository of all film and video related materials;
15	(d) Establish the National Film Institute Jos (in this Bill referred to
16	as The 'Institute, which shall;
17	(i) provide training and capacity building for The Nigerian Motion
18	Picture Industry for the development of highly technical and professionally
19	competent film practitioners to acquire, skills and techniques in film
20	production, management, finance, markets and exhibition; expose each of
