AN ACT TO AMEND THE ECONOMIC AND FINANCIAL CRIMES COMMISSION (ESTABLISHMENT, ETC) ACT, 2004 LAWS OF THE FEDERATION OF NIGERIA CAP E1

Commencement ENACTED by the National Assembly of the Federal Republic of Nigeria as follows: Financial Crimes Commission 1. The Economic and 1 (Establishment etc.) Act, 2004 CAP E1 (in this Bill referred to as the 2 "Principal Act") is amended as set out in this Bill. 3 2. The Principal Act is hereby amended in Section 31(2) by Amendment of 4 Section 31(2) inserting after "Consolidated Revenue Fund of the Federation" the words 5 "in the case of property of the Federal Government or any of its agencies or 6 authorities, and to the Consolidated Revenue Fund of a State Government 7 where the property originally belonged to a State Government or any of its agencies or mutatis mutandis to a Local Government or to a private person 9 where the victim of the fraud is a private individual". 10 3. The Principal Act is hereby amended in Section 31 by inserting Amendment of 11 Section 31 a new Sub Section 5 as follows: 12 "References in Sections 20, 21, 22 and 24 to the Federal 13 Government shall be construed as Federal Government where the crime 14 pertains to the Federal Government's assets, but where the crime has to do 15 with the property, assets or money of State or Local Governments or private 16 individuals then final disposal of such property, assets or money or refund as 17 the case may be shall be to the State or Local Government or individual 18 concerned in accordance with the above provisions". 19
