AN ACT TO AMEND THE ELECTORAL ACT CAP. E6 LFN 2010, AND FOR RELATED MATTERS, 2016

20	12. In this Bill:	Interpretation	
21	"Nigerians in Diaspora" means persons who are citizens of Nigeria		
22	according to the 1999 Constitution and are resident outside Nigeria;		
23	"Diaspora voters" are Nigerians resident outside the country who comply		
24	with the conditions as to be set out by the Commission before they can vote		
25	outside Nigeria.		
26	13. This Bill may be cited as Electoral Act (Amendment) Bill,	Short Title	
27	2016.		

## EXPLANATORY NOTE

This Bill seeks to amend the Electoral Act to incorporate Diaspora voting in the Presidential Elections in the Nigeria Electoral Act, 2010, as a germane amendment to the promotion of Democracy in the country.
