6	(3) Members of the committee shall receive allowances as applicable
7	to government agencies.
8	(4) The committee's duties shall be to-
9	(a) Establish and manage an ICT platform for harmonization of
10	registration, result notification and validation processes of examinations
11	mentioned in sub-clause (1) of this clause into a single scratch card;
12	(b) Establish and manage a central database for collation of personal
13	data and biometrics of candidates for the purpose of the examinations;
14	(c) Fix fees payable to the credit of the platform for the examinations;
15	(d) Reduce the cost of taking the examinations to the barest minimum,
16	through economies of scale;
17	(e) Reduce cases of impersonation and examination malpractice;
18	(f) Provide admission management service to education institutions,
19	planners and monitoring bodies; and
20	(g) Perform other functions that will give effect to the provisions of

	EXPLANATORY MEMORANDUM

Citation

This seeks to amend the Joint Admissions and Matriculation Board Act Cap J1, Laws of the Federation of Nigeria 2004, to establish a steering committee to be vested with the responsibility of centralizing management of the Unified Tertiary Matriculation Examinations (UTME), the National Business and Technical Examinations (NABTE) and the Senior School Certificate Examination (SSCE) under a single ICT platform, to reduce the cost of taking the examinations.
