AN ACT TO PROVIDE FOR THE ESTABLISHMENT OF A RURAL AREAS DEVELOPMENT AGENCY TO PROVIDE FOR THE ECONOMIC AND SOCIAL SUSTAINABILITY OF RURAL AREAS IN NIGERIA

Commencement BE IT ENACTED by the National Assembly of the Federal Republic of Nigeria as follows: 1.-(1) There is established a body to be known as "the Rural Areas 1 Establishment of Development Agency" (in this Act referred to as the "Agency"). 2 the Rural Areas Development (2) The Agency shall be a body corporate with perpetual Agency 3 succession and a Common seal and may sue and be sued in its corporate 5 name. 2.-(1) There is hereby established for the Agency a Board, charged 6 Establishment with the administration of Agency which shall consist of the following: 7 of the Board 8 (a) A Chairman; (b) Six Representatives, each from the six geo-political zones of 9 10 Nigeria; (c) A representative each of the following Federal Ministries, who 11 shall be ex-Officio members: 12 13 (i) Works; 14 (ii) Water Resources: 15 (iii) Environment; 16 (iv) Agriculture; 17 (v) Health; 18 (vi) Power; 19 (vii) National Planning Commission. 16	(2) The Board shall not accept any gift if the conditions attached by	
17	the person or Organisation making the gift is inconsistent with the	
18	realization of the objectives of this Act.	
19	12(1) The Board shall cause to be prepared not later than 30th	Annual Reports
20	August in each year estimates of its expenditure and income during the next	estimates of accounts and audit
21	succeeding year and shall submit same through the President to the national	
22	Assembly for appropriation.	
23	(2) The Board shall keep proper accounts and records of its	
24	activities and such accounts shall be audited by auditors appointed from the	
25	list of auditors and in accordance with the guidelines supplied by the	
26	Auditor-General of the Federation.	
27	(3) Such accounts and records as in (2) above shall include the	
28	detailed activities of the Board and the administration of the Fund and shall	
29	be submitted to the President not later than the 30th of September of every	
30	year.

	18	"Board" means the Board Rural Areas Development Agency established under

	22	"President" means the President of the Federal Republic of Nigeria;
	23	"rural area" means any part of Nigeria which is neither urban or semi urban.
	24	"Six geo-political zones" means: North-Central; North-East; North-West,
	25	South-East; South-South; and South-West.

1	SCHEDULE 1
2	Proceedings of the Board
3	1(1) Subject to this Act and to Section 26 of the Interpretation Act,
4	the Board may make Standing Orders regulating the proceedings of the
5	Board or of any of its Committees established for any purpose.
6	(2) The quorum of the Board shall be 10 members and the quorum
7	of any Committee shall be determined by the Board.
8	2(1) The Board shall meet not less than 4 times in each year and,
9	provided that the Board shall meet whenever it is summoned by the
10	chairman, or if the chairman is required to do so by notice given to him by
11	not less than 5 other members which latter meeting shall hold within 14 days
12	from the receipt of the notice.
13	(2) At a meeting of the Board, the Chairman shall preside, but if he
14	absent, the members present, shall, by majority vote, appoint of the
15	members to preside at the meeting.
16	(3) Where the Board desire to obtain the advice of any person on a
17	particular matter, the Board may co-opt him as a member for such period as
18	it thinks fit, but a person who is a member by virtue of this sub-paragraph
19	shall not be entitled to vote at any meeting of the Board and shall not count
20	towards a quorum.
21	Committees
22	3(1) The Board may appoint one or more Committees to carry out
23	on its behalf, such of its functions as the Board may determine.
24	(2) A Committee appointed under this paragraph shall consist of
25	such number of persons as may be determined by the Board and a person
26	other than a member of the Board shall hold office on the committee in
27	accordance with the terms of his appointment.
28	(3) A decision of a Committee established in sub-paragraph of this
0	naragraph shall require the retification of the Board forwall dita

1	Miscellaneous
2	4(1) The fixing of the seal of the Board shall be authenticated by the
3	signature of the Chairman or of some other member authorised generally or
4	specifically to act for that purpose by the Board.
5	(2) Any contract or instrument which, if made or executed by a person
6	not being a body corporate, would not be required to be under seal may be made
7	or executed on behalf of the Board by the Executive Secretary or any person
8	generally or specifically authorised to act for that purpose by the Board.
9	(3) Any document purporting to be a document duly executed under
10	the seal of the Board shall be received in evidence and shall, unless the contrary
11	is provided, be presumed to be so executed.
12	(4) The validity of any proceeding of the Board or of a Committee
13	shall not be adversely affected by any vacancy in the membership of the Board
14	or a Committee or by any defect in the appointment of any member of the
15	Board or of a committee or by reason only that a person is not entitled to take
16	part in the proceedings.
17	(5) Any member of the Board or any person holding office on a
18	Committee of the Board who has a personal interest in any contract or
19	arrangement entered into or proposed to be considered by the Board or a
20	committee shall forth with disclose his interest to the Board or committee and
21	shall not vote on any question relating to the contract or arrangement.
