ENACTED by the National Assembly of the Federal Republic of Nigeria-

1. The Nigeria Reinsurance Corporation Act Cap. N 131 Laws of 1 Amendment of Cap. N131, LFN the Federation of Nigeria, 2004 (in this Bill referred to as "the Principal 2 2004 3 Act") is amended as set out in this Bill. 2.
