## EXPLANATORY MEMORANDUM

The Bill seeks to amend the National Planning Commission Act CAP N66, LFN, 2004 to provide for the office of a Registrar of non-governmental organizations who shall be a Director in the Commission and shall be saddled with the responsibility of coordinating the activities of non-governmental organizations registered under this Bill in order to streamline all developmental efforts in the country towards a more holistic national planning and development.
