AN ACT TO ALTER SECTION 136 & 181 OF THE CONSTITUTION OF THE FEDERAL REPUBLIC OF NIGERIA 1999 TO PROVIDE FOR DEATH OF THE PRESIDENT OR VICE PRESIDENT DURING AN ONGOING ELECTION OR THE DEATH OF GOVERNOR OR DEPUTY GOVERNOR DURING ONGOING ELECTIONS AND FOR RELATED MATTERS

1 Commencement

BE IT ENACTED by the National Assembly of the Federal Republic of Nigeria as follows:

1. Section 136 of the Constitution of the Federal Republic of Nigeria 1999 (as amended) (hereinafter referred to as "the Constitution") is hereby amended by adding a new section 136B immediately before the existing 137 and it shall read as follows:

Alteration of Section 136 of the Constitution

"136 B (1) If a Candidate for the office of the President of the Federal Republic of Nigeria dies during an ongoing election before conclusion of the said election, the Vice-Presidential Candidate shall be allowed to continue and conclude the election and if he wins, the Vice-Presidential Candidate shall be sworn in as elected President and he shall in turn nominate a new Vice President with the approval by simple majority of the National Assembly at Joint Sitting.

136B (2) If the Vice-Presidential Candidate of the Political Party dies during an ongoing election or before the announcement of Presidential Election Result, the Presidential Candidate shall be allowed to conclude the Election, and if he wins or emerges victorious, he shall nominate a Vice-President to replace the deceased with the approval by simple majority of the National Assembly at Joint Sitting."

"136B (3) Where the Persons duly nominated, by a Political Party

Nigeria, dies during the Presidential election, that is, after the commencement of poll but before the conclusion of the Presidential election, the Independent National Electoral Commission shall immediately cancel the ongoing election and conduct fresh gubernatorial election within three(3) weeks and the political party shall be allowed to nominate new candidates for the fresh Presidential election."

Alteration of Section 181 of the Constitution 2. Section 181 of the Constitution of the Federal Republic of Nigeria 1999 (as amended) (hereinafter referred to as "the Constitution") is hereby amended by adding a new section 181B immediately before the existing 181 and it shall read as follows:

"181B if a Candidate for the office of the Governor of a State within the Federal Republic of Nigeria dies during an ongoing election, the Deputy Gubernatorial Candidate shall be allowed to continue and conclude the election and if he wins, the Deputy Gubernatorial Candidate shall be sworn in as an elected Governor and shall in turn nominate a new Deputy Governor with the approval by simple majority of the State House of Assembly.

181B (2) if the Deputy Gubernatorial Candidate of any Political Party for the election of a State in the Federal Republic of Nigeria dies during an ongoing election or before the announcement of the Gubernatorial Election result, the Gubernatorial Candidate shall be allowed to continue and conclude the election and if he wins, he shall nominate a new Deputy Governor to replace the deceased with the approval of simple majority of the State House of Assembly".

"181B (3) Where the Persons duly nominated, by a Political Party for the Election of Governor and Deputy Governor of a State, dies during the gubernatorial election, that is, after the commencement of poll but before the conclusion of the gubernatorial election, the Independent National Electoral Commission shall immediately cancel the ongoing election and conduct fresh gubernatorial election within two(2) weeks and the political party shall be

EXPLANATORY MEMORANDUM

This Bill seeks to amend the provisions of section 136 and 181 of the Constitution of the Federal Republic of Nigeria by providing that the President and Vice-President, Governor and Deputy Governor have a Joint Ticket and as such where any of them dies during an election, the other should be allowed to continue the election.
