## ENACTED by the National Assembly of the Federal Republic of Nigeria -

1. The Mortgage Institutions Act Cap. M19, Laws of the Federation of Nigeria, 2004 (in this Act referred to as "the Principal Act") is amended as set out in this Act.

Amendment of Cap. M19, LFN, 2004

2. Sections 1 (2) and (3) and 2 (7) and 17 (3) of the Principal Act are amended by substituting for the expression, "N100", the expression, "N1000".

Amendment of sections 1, 2 and 17

3. Section 15 (4) of the Principal Act is amended by substituting for the expression, "N200", the expression, "N20,000".

Amendment of section 15

4. Sections 20 and 21 of the Principal Act are amended by substituting for the expression, "N10,000", the expression, "N100,000".

Amendment of sections 20 and 21

5. This Act may be cited as the Mortgage Institutions (Amendment) Act, 2016.
