AN ACT TO MAKE PROVISIONS FOR FEDERAL GRANTS TO LAGOS STATE IN RECOGNITION OF ITS STRATEGIC SOCIO-ECONOMIC SIGNIFICANCE AND FOR OTHER CONNECTED PURPOSES.

Sponsored by Senator Oluremi Tinubu BE IT ENACTED by the National Assembly of the Federal Republic of Nigeria as follows: 1.-(1) In recognition of the subsisting level of institutions and Designation Lagos State for economic activities in Lagos state under the financial and administrative Special Economic Assistance control of the Federal Government, Lagos State is hereby designated for Special Economic Assistance. 4 (2) By virtue of its designation, Lagos State shall be qualified for a special economic assistance programme in such terms as are established by 6 this Act. 8 2.-(1) The Federal Government shall pay to Lagos State a financial grant in aid to supplement the revenue accruable to the State from the 9 Federation Account. 10 11 (2). The financial grant payable under this section shall be determined for each year by the President on advice by the Governor of 12 13 Lagos State having regard to the total revenues accruing to the Federation Account directly from taxes, levies, duties and other charges on individuals 14 15 and corporate bodies as well as transactions within the territory of Lagos 16 State: 17 Provided that: 18 (a) the financial grant shall not be less that 1% of the share of revenue allocated to the Federal Government in the Federation Account; and 19 20 (b) be payable only upon appropriation by the National Assembly

agencies shall be procured through the members appointed by the President while information required from State agencies shall be procured through the members appointed by the Governor; 4 (b) formulate general policy guidelines for the discharge of its functions; 6 (c) regulate its proceedings and make standing orders with respect to holding of its meetings, notices to be given, the keeping of minutes of its proceedings and such other matters as the Committee may from time to time 8 9 determine. Emolument etc. 10 8.-(a) There shall be paid to the members of the Committee such members sitting allowances and benefits as may be determined by the Lagos State 11 government from time to time. Interpretation 13 9. In this Bill: 'Governor' means the Governor of Lagos State; 14 'President' means the President of the Federal Republic of Nigeria. 15 Citation 16 10. This Bill may be cited as the Lagos State Special Economic Assistance Bill, 2015.

EXPLANATORY MEMORANDUM

The Bill seeks to grant special grant to Lagos State in recognition of its importance as the former Federal Capital of Nigeria and the Commercial nerve centre, its unique mega city status and its strategic socio-economic significance in Nigeria.

In addition, the Bill seeks the provision of financial grants to Lagos State pursuant to section 164(1) of the 1999 Constitution.
