4	(g) accept gifts, grants, bequests and devises made to the Commission

6	vested in the Commission on trust; and	
7	(h) erect buildings and structures and carry out works; and	
8	(i) obtain commercial sponsorship for the Commission and	
9	participate in marketing arrangements involving the endorsement by the	
10	Commission of products and services associated with sport;	
11	(j) arrange for the manufacture of, and distribute (whether by way of	
12	sale or otherwise), any article or thing bearing a mark, symbol or writing that is	
13	associated with the Commission; and	
14	(m) provide (whether by sale or otherwise) goods and services to	
15	persons using, or otherwise attending at, facilities of the Commission; and	
16	(n) do anything incidental to carrying out any of its powers.	
17	(2) The Commission may charge such fees, or impose such charges,	
18	as are reasonable in respect of:	
19	(a) access to, or use of, any of the resources or facilities of the	
20	Commission;	
21	(b) the provision of programs, services, information or	
22	advice by the Commission; and	
23	(c) the admission of persons to events and activities conducted by the	
24	Commission.	
25	(3) The powers of the Commission may be exercised within or outside	
26	Nigeria.	
27	6(1) the Commission shall arrange for the registration of the	
28	company known as the "Nigerian Sports Foundation" as soon as practicable	
29	after the commencement of this Act.

	1	(c) The office of a member of the Council other than a member
*	2	appointed by virtue of office shall be vacated-
	3	(i) if he dies;
	4	(ii) if he ceases to be qualified;
	5	(iii) if he becomes bankrupt, lunatic or of unsound mind;
	6	(iv) if he absents himself from three consecutive meetings without
	7	leave of the Council; or
	8	(v) in the event of his resignation being accepted by the Minister.
	9	(4) Subject to the provisions of this Act the Council may determine its
