An Act to Amend the Code of Conduct Bureau and Tribunal Act, Cap. C15, LFN, 2004; and for other Related Matters

Sponsored by Senator Peter Nwaboshi (Delta North)

[ Commence-ment.

ENACTED by the National Assembly of the Federal Republic of Nigeria as follows—

1. The Code of Conduct Bureau and Tribunal Act, Cap. C15, Laws of the Federation of Nigeria, 2004 (in this Bill referred to as "the Principal Act") is amended as set out in this Bill.

Amendment of Cap. C15, LFN, 2004.

2. Section 3 of the Principal Act is amended by rearranging subsections (c) to now become subsection (b) and subsection (b) to now become subsection (c) as follows:

Amendment of Section 3.

"(c) examine the assets declarations and ensure that they comply with the requirements of this Act and of any Law for the time being in force if otherwise the Bureau shall invite the public officer concerned and take down his statement in writing".

Subsection 3 (d) is amended by deleting the proviso thereto and redrafted as follows:

"(d) receive complaints about non-compliance with or breach of this Act and where the Bureau having regard to any statement taken or to be taken after such subsequent complaint is made considers it necessary to do so, investigate the complaint and where appropriate refer such complaints to the Code of Conduct Tribunal established by section 20 of this Act and the Constitution in accordance with the provisions of sections 20 to 25 of this Act".
