	15	taking into account indigenous cultures and the need to enhance national unity;
	16	(h) to encourage and promote scholarship and conduct research in

by the University and have satisfied such other requirements as the University

4	(f) award honorary degrees, fellowships or academic titles;
5	(g) demand and receive from any student or any other person
6	attending the University for the purpose of instruction such fees as the
7	University may from time to time determine, subject to the overall directives of
8	the appropriate authority;
9	(h) subject to section 22 of this Act, to acquire, hold, grant, charge or
10	otherwise deal with or dispose of movable and immovable property wherever
11	situate;
12	(i) accept gifts, legacies and donations, but without obligation to
13	accept the same for a particular purpose unless it approves the terms and
14	conditions attaching thereto;
15	(j) enter into contracts, establish trusts, act as trustee, solely or jointly
16	with any other person, and employ and act through agents;
17	(k) erect, provide, equip and maintain libraries, laboratories, lecture
18	halls, halls of residence, refectories, sports grounds, playing fields and other
19	buildings or things necessary, suitable or convenient for any of the objects of
20	the University;
21	(1) hold public lectures and undertake printing, publishing and book
22	selling;
23	(m) subject to any limitations or conditions imposed by Statute, to
24	invest any moneys appertaining to the University by law of endorsement,
25	whether for general or special purposes, and such other moneys as may not be
26	immediately required for current expenditure, in any investments or securities
27	or in the purchase or improvement of land, with power from time to time to vary
28	any such investments and to deposit any moneys for the time being un-invested
29	with any bank on deposit or current account;
30	(n) borrow whether on interest or not and if need be upon the

1	security of any or all of the property movable or immovable of the	
2	University, such moneys as the Council may from time to time in its	
3	discretion find necessary or expedient to borrow or to guarantee any loan,	
4	advances or credit facilities;	
5	(o) make gifts for any charitable purpose;	
6	(p) do anything which it is authorized or required by this Act or by	
7	any other Statute to do; and	
8	(q) do all such acts or things, whether or not incidental to the	
9	foregoing powers, as may advance the objects of the University.	
10	(2) Subject to the provisions of this Act and of the Statutes made	
11	thereunder and without prejudice to Section 9 (2) of this Act, the powers	
12	conferred on the University by subsection (1) of this section shall be	
13	exercisable on behalf of the University by the Council or by the Senate or in	
14	any other manner which may be authorized by this Act.

nance and general urpose	10	Council shall be the Governing Body of the University and shall be charged
	11	with the general control and superintendence of the policy, finances and
	12	property of the University, including its public relations.
	13	(2) There shall be a committee of the Council to be known as the
	14	Finance and General Purposes Committee, which shall, subject to the
	15	directions of the Council, exercise control over the property and expenditure of
	16	the Council as the Council may from time to time delegate to it.
	17	(3) Provision shall be made by Statute with respect to the constitution
	18	of the Finance and General Purposes Committee.
	19	(4) The Council shall ensure proper accounts of the University are
	20	kept and that the accounts of the University are audited annually by auditors
	21	appointed by the Council from the list and in accordance with guidelines
	22	supplied by the Auditor-General of the Federation, and that an annual report is
	23	published by the University together with certified copies of the said accounts
	24	as audited.
	25	(5) Subject to this Act and the Statutes, the Council and the Finance
	26	and General Purposes Committee may each make rules for the purpose of
	27	exercising any of their respective functions or of regulating their own
	28	procedure.
	29	(6) Rules made under subsection (S) of this section by the Finance and
	30	General Purposes Committee shall not come into force unless approved by the

1	Council, and where any rule so made by the Committee conflict with any	
2	directions given by the Council (whether before or after the coming into

15	PROVIDED that if after 28 days of the receipt or delivering to him of	
16	such request, the chairman fails or neglects to call a meeting, the Registrar	
17	shall within 14 days thereof, cause a meeting of the Council to be convened

19	the meeting and no business not so specified shall be transacted at that	
20	meeting.

9	(d) making of recommendations to the Council with respect to the
10	award to any person of an honorary fellowship or honorary degree or the title of
11	professor emeritus;
12	(e) establishment, organization and control of halls of residence and
13	similar institutions in the University;
14	(f) supervision of the welfare of students in the University and the
15	regulation of their conduct;
16	(g) granting of fellowships, scholarships, prizes and similar awards in
17	so far as the awards are within the control of the University; and
18	(h) determination of what description of dress shall be academic dress
19	for the purposes of the University, and regulating the use of academic dress.
20	(3) The Senate shall not establish any new campus, college, faculty,
21	department, school, institute or other teaching and research units of the
22	University, or any hall of residence or similar institution at the University
23	without the approval of the Council.
24	(4) (a) Subject to this Act and the Statutes, the Senate may make
25	regulations for the purpose of exercising any function conferred on it either by
26	the provisions of this section or for the purpose of providing for any matter for
27	which provision by regulation is authorized or required by this Act or by
28	Statute;
29	(b) The Senate shall, by regulation, provide that at least one of the

persons appointed as examiners at each final or professional examination held

l	in conjunction with any course of study in the University is not a teacher at	
2	the University but is a teacher at the branch of learning to which the course

ļ	(5) Subject to a right of appeal to the Council from a decision of the	
5	Senate under this subsection, the Senate may deprive any person of any	
5	degree, diploma or other award of the University which has been conferred	
7	on him if after due enquiry he is shown to have been guilty of any	
3	dishonourable or scandalous conduct in gaining admission into the	
)	University or obtaining that award.	
10	9(1) The Vice-Chancellor shall, in relation to the University, take	Functions of the Vice Chancellor
11	precedence before all other members of the University except the	vice Chancellor
12	Chancellor and, subject to section 5 of this Act, the Pro-Chancellor and any	
13	other person for the time being acting as Chairman of the Council.	
14	(2) Subject to the provisions of this Act, the Vice-Chancellor shall	
15	have general function, in addition to any other functions conferred on him	
16	by this Act or otherwise, of directing the activities of the University, and	
17	shall to the exclusion of any other person or authority be the chief executive	
18	and academic officer of the University and ex-officio Chairman of the	
19	Senate.

29	11(1) Subject to this Act, the University may make Statutes for any	Power of the

	3	(b) specifying and regulating the powers and duties of any authority
	4	of the University, and regulating any other matter connected with the
	5	University or any of its authorities;

	7	University, and their discipline and welfare;
	8	(d) determining whether any particular matter is to be treated as an
	9	academic or non-academic matter for the purposes of this Act and of any
	10	Statute, regulation or other instrument made there-under; and
	11	(e) making provision for other matters for which provision by Statute
	12	is authorized or required by this Act.
	13	(2) Subject to section 25 (6) of this Act, the Interpretation Act shall
	14	apply in relation to any Statute made under this section as it applies to a
	15	subsidiary instrument within the meaning of section 27 (1) of that Act.
	16	(3) The Statute contained in the Third Schedule to this Act shall be
	17	deemed to have come into force on the commencement of this Act and shall be
	18	deemed to have been made under this section by the University.
	19	(4) The power to make Statute conferred by this section shall not be
	20	prejudiced or limited in any way by reason of the inclusion or omission of any
	21	matter in or from the Statute contained in the Third Schedule to this Act or any
	22	subsequent Statute.
Mode of exercising the power to make	23	12(1) The power of the University to make Statutes shall be
Statutes Statutes	24	exercised in accordance with the provisions of this section.
	25	(2) A proposed Statute shall not have the force of law until it has been
	26	approved at a meeting of the-
	27	(a) Senate, by the votes of not less than two thirds of the members
	28	present and voting; and
	29	(b) Council by the votes of not less than two thirds of the members
	30	present and voting.

I	(3) A proposed Statute may originate either in the Senate or		
2	Council, and may be approved as required by subsection (2) of this section		
3	by both bodies in no particular order.		
4	(4) A Statute which-		
5	(a) makes provision for or alters the composition or constitution of		
6	the Council, the Senate or any other authority of the University; or		
7	(b) provides for the establishment of a new campus or college or for		
8	the amendment or revocation of any Statute whereby a campus or college is		
9	established;		
10	shall not come into operation unless it has been approved by the Visitor.		
11	(5) For the purpose of section 2 (2) of the Interpretation Act, a		
12	Statute shall be treated as being made on the date on which it is approved by		
13	the Council and the Senate in accordance with subsection (3) of this section		
14	or in the case of a Statute falling within subsection (4) of this section, on the		
15	date on which it is approved by the President.		
16	13. A Statute may be proved in any court by the production of a	Proof of Statute	
17	copy thereof bearing or having affixed to it a certificate signed by the Vice-		
18	Chancellor or the Registrar to the effect that the copy is a true copy of a		
19	Statute of that University.		
20	14(1) In the event of any doubt or dispute arising at any time as to	Power to decide the meaning of	
21	the meaning of any provision of a Statute, the matter may be referred to the	Statute	
22	Visitor, who shall take such advice and make such decision thereon as he		
23	deems fit.		
24	(2) The decision of the Visitor on any matter referred to him under		
25	this section shall be binding upon the authorities, staff and students of that		
26	University and where any question as to the meaning of any provision of a		
27	statute has been decided by the Visitor under this section, no question as to		
28	the meaning of that provision shall be entertained by any other authority in		
29	Nigeria:		
30	PROVIDED that nothing in this subsection shall affect the power		

	1	of a court of competent jurisdiction to determine whether any provision of a
	2	statute is wholly or partly void as being ultra vires or as being inconsistent with
	3	the Constitution.
	4	(3) The foregoing provisions of this section shall apply in relation to
	5	any doubt or dispute as to whether any matter is, for the purposes of this Act,
	6	academic or a non-academic matter as they apply in relation to any such doubt
	7	or dispute as is mentioned in subsection (1) of this section, and accordingly the
	8	reference in subsection (2) of this section to any question as to the meaning of
	9	any provision of a statute shall include references to any question as to whether
	10	any matter is for the said purposes an academic or non-academic matter.

	23	this Act which may be given by the Visitor in consequence of the visitation.

Council	25	Chancellor or the Vice-Chancellor) should be removed from office on grounds
	26	of misconduct or inability to perform the functions of his office, the Council
	27	shall make a recommendation to that effect through the Minister to the
	28	Maritime university of Nigeria Oron Executive Council and if the Maritime
	29	university of Nigeria Oron Executive Council, after making such enquiries (if
	30	any) as may be considered necessary, approves the recommendation it may

2	(2) It shall be the duty of the Minister to use his best endeavours to
3	cause a copy of the instrument embodying a direction under subsection (1)
4	of this section to be served as soon as reasonably practicable on the person to
5	whom it relates.
6	17(1) If it appears to the Council that there are reasons for
7	believing that any person employed as a member of the academic,
8	administrative or professional staff of the University, other than the Vice-
9	Chancellor, should be removed from office or on grounds of misconduct or
10	inability to perform the functions of his office Council shall-
11	(a) give notice of those reasons to the person in question;
12	(b) afford such person an opportunity of making representation in
13	person on the matter to the Council; and
14	(c) take a decision to terminate or not to terminate the appointment.
15	(2) If the affected staff or any three members of the Council so
16	request within a period of one month from the date of receipt of the notice of
17	the Council's decision, the Council shall make arrangements for-
18	(a) a joint committee of the Council and the Senate to review the
19	matter and to report on it to the Council;
20	(b) the person in question to be afforded an opportunity to appear
21	before and be heard by an investigating committee with respect to the
22	matter;
23	and if the Council after considering the report of the investigating
24	committee, is satisfied that the person in question should be removed, the
25	Council may so remove him by an instrument in writing signed on the
26	directions of the Council.
27	(3) The Vice-Chancellor may, in a case of gross misconduct by a
28	member of staff which in the opinion of the Vice-Chancellor is prejudicial to
29	the interest of the University, suspend such member and any such

 $suspension\ shall\ immediately\ be\ reported\ to\ the\ Council.$

- 1 (4) Any member of staff may be suspended from duty or his appointment may
- 2 be terminated by Council for a good cause and for the purposes of this
- 3 subsection "good cause" means-
- 4 (a) conviction for any offence which the Council considers to be such as to
- 5 render the person concerned unfit for the discharge of the functions of his
- 6 office;
- 7 (b) any physical or mental incapacity which the Council, after obtaining
- 8 medical advice, considers to be such as to render the person concerned unfit to
- 9 continue to hold office;
- 10 (c) conduct of a scandalous or disgraceful nature which the Council considers
- to be such as to render the person concerned unfit to continue to hold office; or
- 12 (d) conduct which the Council considers to be such as to constitute failure or
- inability of the person concerned to discharge the functions of his office or to
- 14 comply with the terms and conditions of his service.
- 15 (5) Any person suspended pursuant to subsection (3) of this section shall be on
- half pay and the Council shall before the expiration of a period of three months
- 17 from the date of such suspension consider the case against that person and
- 18 come to a decision as to whether to-
- 19 (a) continue such person's suspension and if so on what terms (including the
- 20 proportion of his emoluments to be paid to him);
- 21 (b) reinstate such person in which case the Council shall restore his full
- 22 emoluments with effect from the date of suspension;

	12	section, the Senate shall, after causing such inquiry to be made in the matter as

11	prescribed qualifications as the Board may determine; and
12	(d) such persons whether or not members of the University as the
13	Board may determine with the general or special approval of Senate.
14	(3) The quorum of the Board shall be eight members or one-quarter of
15	the members of the Board for the time being whichever is greater.
16	(4) Subject to the provisions of this statute and to any provision made
17	by regulations in that behalf, the Board may regulate it own procedure.
18	The Dean of the Faculty
19	8(1) The Dean of a faculty shall be a professor elected by the Faculty
20	Board and such Dean shall hold office for a term of two years. He will be
21	eligible for re-election for another term of two years after which he may not be
22	elected again until two years have elapsed.
23	(2) If there is no professor in a faculty, the Vice-Chancellor shall
24	appoint an Acting Dean who shall not be below the rank of Senior Lecturer for
25	the faculty, who will act for a period of one year in the first instance, renewable
26	for another one year only.
27	(3) In the absence of the Vice-Chancellor, the Dean shall be the
28	chairman at all meetings of the Faculty Board when he is present and he shall be
29	a member of all committees and other boards appointed by the faculty.
30	(4) The Dean of a faculty shall exercise general superintendence over

1	the academic and administrative affairs of the faculty and it shall be the
2	function of the Dean to present to the convocation for the conferment of
3	Degrees, persons who have qualified for the Degrees of the University at
4	examinations held in the branches of learning for which responsibility is
5	allocated to that faculty.
6	(5) There shall be a committee to be known as the Committee of
7	Deans which shall consist of all the Deans of the several faculties and that
8	committee shall advise the Vice-Chancellor on all academic matters and on
9	particular matters referred to the Committee by the Senate.
10	(6) The Dean of a faculty may be removed from office for a good
11	cause by the Faculty Board after a vote would have been taken at a meeting
12	of the Board, and in the event of a vacancy occurring following the removal
13	of the Dean, an Acting Dean may be appointed by the Vice-Chancellor
14	provided that at the next faculty board meeting an election shall be held for a
15	new Dean.
16	(7) In this article, "good cause" has the same meaning as in section
17	17 (4) of this Act.
18	Selection of Certain Principal and other key Officers
19	9(1) When a vacancy occurs in the Office of the Registrar, Bursar,
20	the University Librarian, Director of Works or Director of Health Services, a
21	Selection Board shall be constituted by the Council and shall consist of-
22	(i) the Pro-Chancellor;
23	(ii) the Vice-chancellor;
24	(iii) two members appointed by the Council, not being members of
25	Senate; and
26	(iv) two members appointed by the Senate not being members of
27	Council.
28	(2) The Selection Board, after making such inquires as it thinks fit,
29	shall recommend a candidate to the Council for appointment to the vacant
30	office, and after considering the recommendation of the Board the Council

1	may make an appointment to that office.
2	(3) A person appointed to the office of Director of Works or Director
3	of Health Services shall hold office for such period and on such terms and
4	conditions as may be specified in his letter of appointment.
5	Creation of Academic Post
6	10. Recommendation for the creation of posts other than those
7	mentioned in paragraph 9 of this Schedule shall be made by the Senate to the
8	Council through the Finance and General Purposes Committee.
9	Appointment of Academic Staff
10	11. Subject to this Act and the Statutes derived from it, the filling of
11	vacancies in academic posts (including newly created ones) shall be as
12	prescribed from time to time by Statutes.
13	Appointment of Administrative and Technical Staff
14	12(1) The administrative and technical staff of the University, other
15	than those mentioned in paragraph 9 of this schedule shall be appointed by the
16	Councilor on its behalf by the Vice-Chancellor or the Registrar in accordance
17	with any delegation of powers made by the Council in that behalf.
18	(2) In the case of administrative or technical staff that has close and
19	important contacts with the academic staff, there shall be Senate participation
20	in the process of selection.
