	BE IT ENACTED by the National Assembly of the Federal			
	Republic of Nigeria as follows:			
1	1. The Constitution of the Federal Republic of Nigeria 1999 (as	Amendment of		
2	amended) (in this Act referred to as "the Principal Act") is hereby further	the Principal Act		
3	amended as set out in this Act.			
4	2. Sub-section 308(2) of the Principal Act is substituting for the			
5	following new subsection:			
6	"(2) The provisions of subsection (1) of this section shall not apply			
7	to-			
8	(a) civil proceedings against a person to whom this section applies	4		
9	in his official capacity or to civil or criminal proceedings in which such a			
10	person is only a nominal party;			
11	(b) criminal proceedings connected to, related to or arising from			
12	economic and financial crimes."			
13	Section 308 shall now read as follows:			
14	"(1) Notwithstanding anything to the contrary in this Constitution,			
15	but subject to subsection (2) of this section-			
16	(a) no civil or criminal proceedings shall be instituted or continued			
17	against a person to whom this section applies during his period of office;			
18	(b) a person to whom this section applies shall not be arrested or			
19	imprisoned during that period either in pursuance of the process of any court			
20	or otherwise; and			
21	(c) no process of any court requiring or compelling the appearance			

	1	of a person to whom this section applies, shall be applied for or issued:
•	2	Provided that in ascertaining whether any period of limitation has expired for
	3	the purposes of any proceedings against a person to whom this section applies,
	4	no account shall be taken of his period of office.
	5	(2) The provisions of subsection (1) of this section shall not apply to-
,	6	(a) civil proceedings against a person to whom this section applies in
	7	his official capacity or to civil or criminal proceedings in which such a person is
	8	only a nominal party;
	9	(b) criminal proceedings connected to, related to or arising from
	10	economic and financial crimes.
	1	(3) This section applies to a person holding the office of President or
	.12	Vice-President, Governor or Deputy Governor; and the reference in this
	13	section to "period of office" is a reference to the period during which the person
	14	holding such office is required to perform the functions of the office."
	15	3. Sub-section 68(g) of the Principal Act is deleted.
