

AN ACT TO AMEND THE NIGERIA REINSURANCE CORPORATION ACT CAP. N131 LAWS OF THE FEDERATION OF NIGERIA, 2004 TO PROVIDE FOR THE PAYMENT OF ALL MONIES RECEIVED BY THE CORPORATION INTO THE FEDERATION ACCOUNT IN ACCORDANCE WITH SECTION 162 OF THE CONSTITUTION OF THE FEDERAL REPUBLIC OF NIGERIA 1999 (AS AMENDED). Commencement

ENACTED by the National Assembly of the Federal Republic of Nigeria-

1. The Nigeria Reinsurance Corporation Act Cap. N131 Laws of Amendment of Cap. N131, LFN the Federation of Nigeria, 2004(in this Bill referred to as "the Principal Act") is amended as set out in this Bill. 3 2. Section 11 of the Principal Act is substituted for the following Substitution of new Section 14 new Section 11-5 "11. The Funds of the Corporation shall consist of-6 (a) such funds as budgetary allocations, trust funds, subventions, 7 grants-in-aid and loans as may, from time to time, be made by the Federal 8 Government; 9 (b) such sums or property which may, from time to time by way of 10 loans or grants and gifts accrue to the Corporation form any other 11 Government, non-governmental bodies or individuals; and 12 (c) other monies received by the Corporation which may in any 13 way, become payable to or vested in the Corporation by way of revenues, 14 fees, levies, taxes, penalties, gifts, grants-in-aid, testamentary disposition 15 and all other assets that may from time to time accrue to the Corporation. 16 (2) All monies received by or on behalf of the Corporation shall be

receipted and shall be paid into the Federation Account within 24 hours of receipt or the next working day."
