3	Section 2 (4)
4	SUPPLEMENTARY PROVISION RELATING TO THE BOARD ETC.
5	Procedure of the Council
6	1(1) Subject to this Act and section 27 of the Interpretation Act, the
7	Council may make standing orders regulating its proceedings or those of any of
8	its committees.
9	(2) Every meeting shall be presided over by the Chairman and if the
10	Chairman is unable to attend a particular meeting the members present at the
11	meeting shall elect one of the member to preside at the meeting.
12	(3) The quorum of the Council shall be the Chairman or the person
13	presiding at the meeting and nine other members of the Council.
14	(4) Upon any special occasion, the Council may co-opt any person to
15	be a member for as many meetings as may be necessary, and that person so co-
16	opted shall have all the rights and privileges of a member, except that he shall
17	not be entitled to vote or count towards a quorum.
18	(5) Subject to its standing orders, the Council may set up such number
19	of standing and ad-hoc committees, as it thinks fit, to consider and report on
20	any matter with which the Agency is concerned.
21	(6) Every committee set up under the provisions of subparagraph (5)
22	shall be presided over by a member of the Council and shall be made up of such
23	number of persons, not necessarily members of the Council, as the Council
24	may determine in each case.
25	(7) The decision of a committee shall be of no effect until it is
26	confirmed by the Council.

28	2(1) The fixing of the seal of the Agency shall be authenticated by
29	the signature of the Chairman of the Council or any person authorised to act for
30	that purpose.

l	(2) A contract or instrument, which it made by a person not being a
2	body corporate, would not be required to be under seal, may be made or
3	executed on behalf of the Agency by the Executive Secretary of the Agency
4	(3) A document purporting to be a contract or instrument or other
5	document signed or sealed on behalf of the Agency shall be received in
6	evidence and, unless the contrary is proved, be presumed, without further
7	proof, to have been so signed or sealed.
8	(4) The validity of any proceeding of the Council or a committee
9	shall not be adversely affected by-
10	(a) any vacancy in the membership of the Council;
11	(b) any defect in the appointment of a member of the Council or
12	committee; and
13	(c) reason that a person not entitled to do so took part in the
14	proceeding.

16	Section 6 (a)
17	In the exercise of its powers of enforcement provided for under section 6 (a),
18	the Agency may refer matters to the family court and such other courts
19	established under other relevant laws.
