EXPLANATORY MEMORANDUM

This Bill seeks to alter Item 48 of the Second Schedule (Legislative Powers), Part I of the Exclusive Legislative List of the Constitution of the Federal Republic of Nigeria, 1999 (as altered) to repeal the word "prisons" and re-enact it with the phrase: "correctional centres established by either Federal and State Governments as prescribed under Part II Concurrent Legislative List-Extent of Federal and State Legislative Powers, Second Schedule of the Constitution of the Federal Republic of Nigeria (as altered)" for the purpose of granting legislative powers to State Governments to establish prisons with in accordance with the current efforts of the Federal Government towards decongestion of correctional centres within Nigeria as currently implemented by the Presidential Committee on Decongestion of Correctional Services headed by Hon. Attorney-General and Minister of Justice and also in accordance with the general principles of the Nigerian Correctional Service (Establishment) Act, 2019.
