ENACTED by the National Assembly of the Federal Republic of Nigeria: 1 PART I - ESTABLISHMENT, COMPOSITION AND FUNCTIONS OF THE 2 FEDERAL UNIVERSITY OF TECHNOLOGY OKIJA, ANAMBRA STATE 1.-(1) There is established the Federal University of Technology 3 Okija, Anambra State (in this Bill referred to as "the University"). 4 5 (2) The University: (a) is a body corporate with perpetual succession, and a common 6 7 seal; and (b) may sue or be sued in its corporate name. 8 (3) The University is a training institution for the development of 9 Technical education in the country. 10 (4) The University shall be supervised by the Federal Ministry of 11 Education through the National Universities Commission (NUC) who is 12 responsible for approving and regulating all academic programmes run in 13 the University, to ensure quality compliance and provide funds for academic 14 and research programmes, infrastructures and remunerations of employees. 15 (5) The objectives of the University are to: 16 (a) encourage the advancement of learning and to hold out to all 17 persons without distinction of race, creed, sex or political conviction;
