(2) The person so appointed shall hold office until the expiration of 15 the term of office of the member in whose place he or she is appointed. 16 17

(3) The committee shall notify the minister as soon as a vacancy occurs in the membership of the council, and the minister shall fill the vacancy within three months of receiving the notice.
