ENACTED by the National Assembly of the Federal Republic of Nigeria as follows:

1.-(a) There shall be establishment of a land administration 1 2 committee which may only be disestablished if its existence is no longer 3 required in terms of this Act; (b) In the exercise of the powers and the performance of the duties 4 of a land administration committee as contemplated in sub-section, a 5 6 representative of the traditional council must ensure that the composition of 7 its membership satisfies the requirements; 8 (c) Any provision in this Act which refers, or is applicable to a 9 traditional council is intended to establish norms and standards and a national policy with regards to Communal land, to effect uniformity across 10 the nation. 11 2.-(a) A land administration committee must consist of a total 12 number of m embers as may be determined by the representatives of the 13 14 Minister in consultation with the Local Government political leadership; 15 (b) At least one third of the total membership of a land administration committee must be women; 16 17 (c) One member of a land administration committee must represent the interest of vulnerable members, including women, children, youth, the 18 19 elderly and the disabled;
