FOR RELATED MATTERS Sponsored by Hon Oluwole Oke Commencement BE IT ENACTED by the National Assembly of the Federal Republic of Nigeria as follows: PART I - ESTABLISHMENT, POWERS AND FUNCTIONS OF THE COLLEGE 1 1.-(1) There is hereby established a College to be known as the 2 Establishment and Objects of the Federal College Federal College of Agriculture, Sampou (Kolokurna/Opokuma), Bayelsa 3 of Agriculture, Sampou, (Kolokum/ State (in this Bill referred to as "the College") which shall have such powers 4 Opokuma), Bayelsa 'and exercise such functions as are conferred on it by this Bill. 5 6 (2) The College shall be a body corporate with perpetual succession and a common seal and shall have power to acquire and dispose 7 of interests in movable and immovable properties and may sue and be sued 8 9 in its corporate name. (3) The objects of the College shall be: 10 (a) to encourage the advancement of learning and to hold out to all 11 persons without distinction of race, creed, sex or political conviction, the 12 opportunity of acquiring a higher education in agriculture; 13 (b) to develop and offer academic and professional programmes 14 15 leading to the award of Professional certificates, Ordinary National Diplomas and Higher National Diplomas which emphasise planning, 16 adaptive, technical, maintenance, developmental and productive skills in 17 agriculture, and to contribute to the scientific transformation of agriculture 18 19 in Nigeria;

(c) to act as agents and catalysts, through training, research and

innovation for the effective and economic utilisation, exploitation and

19	(i) recruit staff of the right calibre and determine the career structure
20	of such staff;
21	(j) establish and maintain such schools, institutes, extramural
22	departments and other teaching and research units within the College as the
23	Council may, from time to time, deem necessary;
24	(k) institute and award fellowships, scholarships, medals, prizes and
25	other titles;

(7) The Provost may delegate his powers under this section to a 30

6	1. There may be paid to the members of the Councilor any committee,
7	other than ex-officio members, such remuneration and allowances as may from
8	time to time be determined by the Minister.
9	2. The Council may act notwithstanding any vacancy in its
10	membership or any defect in the appointment of a member or the absence of a
11	member.
12	Proceedings
13	3(1) The Council shall meet for the conduct of business at such
14	times, place, and on such days as the chairman may appoint but shall meet not
15	less than once every four months.
16	(2) The chairman may at any time and shall, at the request in writing of

18	(3) At any meeting of the Council the chairman shall preside; but in
19	his absence, members present shall elect one of their members to preside at the

28	(6) Decisions of the Council shall be made on approval by a simple
29	majority of members.

2	4(1) The fixing of the seal of the College shall be authenticated by
3	the signature of the chairman, Provost and of some other members of the
4	Council authorised generally or specially by the Council to act for that
5	purpose.
6	(2) Any contract or instrument which, if made or executed by a
7	person other than a body corporate would not be required to be under seal
8	may be made or executed on behalf of the College by any person generally or
9	specially authorised to act for that purpose by the Council.
10	(3) Any document purporting to be duly executed under the seal of
11	the College shall be received in evidence and shall, unless the contrary is
12	proved, be presumed to be so executed.

EXPLANATORY MEMORANDUM

This Bill seeks to provide for the establishment of the Federal College of Agriculture, Sampou (Kolokuma/Opokuma), Bayelsa State and to identify the agricultural problems and needs of Nigeria and to find solutions to them within the context of overall national development.
