AN ACT TO ALTER THE SECOND SCHEDULE TO THE CONSTITUTION OF THE FEDERAL REPUBLIC OF NIGERIA, 1999 TO EMPOWER THE NATIONAL ASSEMBLY AND STATE HOUSES OF ASSEMBLY POWERS TO SUMMON THE PRESIDENT OF THE FEDERAL REPUBLIC OF NIGERIA AND GOVERNORS OF STATES TO ANSWER QUESTIONS ON ISSUES ON WHICH THE NATIONAL AND STATE HOUSES OF ASSEMBLY HAVE POWERS TO MAKE LAWS; AND FOR RELATED MATTERS

Commencement. } ENACTED by the National Assembly of the Federal Republic of Nigeria as follows-The Constitution of the Federal Republic of Nigeria 1999 (in this Bill referred to as "the Principal I. Act") is altered as set out in this Bill. Alteration Constitution. Section 67 of the Principal Act is altered by inserting after subsection (3), a new subsection "(4)" -2. Alteration Section 67 (4) Nothing in this section shall preclude the National Assembly from summoning the President of the Federal Republic of Nigeria to attend a joint session of the National Assembly to answer questions on national security or any issue whatsoever, over which the National Assembly has powers 3. Alteration Section 108 of the Principal Act is altered by inserting after subsection (3), a new subsection "(4)" -Section 108 (4) Nothing in this section shall preclude the House of Assembly of the State from summoning the Governor of the State to attend a sitting of the House of Assembly to answer questions on security or on any issue whatsoever, over which the House of Assembly has powers to make laws".

This Bill may be cited as the Constitution of the Federal Republic of Nigeria, (Fifth Alteration) Bill,

This Bill seeks to alter the provisions of the Constitution of the Federal Republic of Nigeria, 1999 in order to grant the two chambers of the National Assembly and States' Houses of Assembly powers to summon the President of the Federal Republic of Nigeria and Governors of States respectively, to answer questions on issues of national security or any matter whatsoever, over which the National Assembly and States' Houses of Assembly, have power to make laws.
