ENACTED by the National Assembly of the Federal Republic of Nigeria as follows: 1 PART 1 - ESTABLISHMENT OF NIGERIAN ASSETS 2 MANAGEMENT AGENCY 3 1.-(1) There is established a body to be known as the Nigerian 4 Assets Management Agency (in this Bill referred to as "the Agency") which 5 shall be constituted in accordance with and shall have functions as are 6 conferred on it by this Bill. 7 (2) The Agency: 8 (a) shall be a body corporate with perpetual succession and a 9 common seal; 10 (b) may sue and be sued in its corporate name and may, for the 11 purpose of its functions as an Agency acquire, hold or dispose of property 12 (whether movable or immovable); 13 (c) is the designated Nigerian Asset Record and Management 14 Center (NARMC) in Nigeria which is charged with the responsibility of 15 managing the various Federal Government assets acquired within and 16 outside the country through seizure, forfeiture, take over or transfer by 17 security agencies empowered to do so.



EXPLANATORY MEMORANDUM

This Bill seeks to establish and regulate the Nigerian Assets Management Agency charged with the responsibility of managing all Government Assets including those seized, forfeited or taken over by Federal Government bodies Such as EFCC, ICPC, Police, Customs, Nigerian Security and Civil defense Corps amongst others.
