AN ACT TO PROVIDE FOR THE ESTABLISHMENT OF FINANCIAL CONTROL DEPARTMENT (FCD) IN THE OFFICE OF THE PRESIDENT FOR THE PURPOSE OF MONITORING FINANCES OF ALL FEDERAL GOVERNMENT MINISTRIES, MATTERS, 2019

EXTRA-MINISTERIAL DEPARTMENTS AND AGENCIES AND FOR RELATED Sponsored by Hon. Johnson Egwakhide Oghuma Commencement ENACTED by the National Assembly of the Federal Republic of Nigeria as follows: 1. There is established the Financial Control Department in the Establishment 1 of the Financial office of the President of the Federal Republic of Nigeria (in this Bill Control Department 2 referred to as the "Department") as set out in this Bill. 3 2. The objectives of the Department shall be: Objectives of 4 the Department (a) To deepen accountability, transparency in the finances of 5 government ministries, extra-ministerial departments and agencies; 6 (b) To enhance internal control processes within Federal 7 Government Revenue Generating Agencies to ensure compliance with the 8 financial Laws, regulations, policies and procedures; (c) To detect and track down unremitted funds domicile in the 10 various Federal Government Ministries, and Extra-Ministerial Departments 11 and Agencies and to ensure such funds are remitted forthwith to the Federal 12 Government: 13 (d) To reconcile all bank accounts and statements of the various 14 Federal Government Ministries, and Extra-Ministerial Departments and 15 Agencies every month, and reports made to the President; and 16 (e) To carry out detailed investigations on any grey areas brought 17 before it by any government ministry, extra-ministerial department and

	9	committed any infraction in handling the finances at its disposal on behalf of
