	Principal Act") is hereby altered as set out hereunder.

	substituting the entire sub-section 3 thereof with a new subsection 3 as

	3. The Principal Act is amended by creating a new section 45 as
	follows:
0	"SECTION 45. FREE, COMPULSORY AND UNIVERSAL BASIC
1	EDUCATION
2	(1) Every citizen of Nigeria is entitled to free, compulsory and
3	universal basic education, and every government in Nigeria shall provide
4	free, compulsory and universal basic education to every child from primary
5	to junior secondary school.
6	(2) It shall be the duty of every parent to ensure that his child or
7	ward attends and completes his primary and junior secondary school
8	education by endeavoring to send the child to primary and junior secondary
9	schools.

	1	(3) Every stakeholder in education shall ensure that every parent or
	2	person who has the care and custody of a child performs the duty imposed on
	3	him under section 45 of this Constitution.
Amendment of Section 318	4	4. Section 318 of the Principal Act is amended in sub-section 1 by the
	5	addition of a new definition paragraph immediately after the definition of the
	6	word "authority" as follows:
	7	"basic education" means free and compulsory education from
	8	primary school to junior secondary school.
	9	5. The Principal Act is hereby amended by renumbering the existing
	10	sections 45 to 318 of the constitution as sections 46 to 319
