# A BILL

## FOR

AN ACT TO PROVIDE FOR THE ESTABLISHMENT OF THE FEDERAL UNIVERSITY OF EDUCATION PANKSHIN, PLATEAU STATE FOR THE PROMOTION AND DEVELOPMENT OF TEACHER EDUCATION IN NIGERIA; AND FOR RELATED MATTERS

*Sponsored by Hon. Gagdi Adamu Yusuf*

ENACTED by the National Assembly of the Federal Republic of Nigeria as follows:

1 PART I - ESTABLISHMENT, COMPOSITION AND FUNCTIONS OF THE  
2 FEDERAL UNIVERSITY OF EDUCATION PANKSHIN, PLATEAU STATE

3 1.-(1) Federal College of Education, Pankshin is upgraded and  
4 established as the Federal University of Education Pankshin, Plateau State  
5 (in this Act referred to as "the University").

Establishment and objectives of Federal University of Education Pankshin, Plateau State

6 (2) The University:

7 (a) is a body corporate with perpetual succession, and a common  
8 seal; and

9 (b) may sue or be sued in its corporate name.

10 (3) The University is a training institution for the development of  
11 teacher education in the country.

12 (4) The University shall be supervised by the Federal Ministry of  
13 Education through the National Universities Commission (NUC) who is  
14 responsible for approving and regulating all academic programmes run in  
15 the University, to ensure quality compliance and provide funds for academic  
16 and research programmes, infrastructures and remunerations of employees.

17 (5) The objectives of the University are to:

18 (a) encourage the advancement of learning and to hold out to all  
19 persons without distinction of race, creed, sex or political conviction;

1 (b) develop and offer academic and professional programmes leading  
2 to the award of certificates, first degrees, post-graduate, diploma and higher  
3 degrees with emphasis on planning, developmental and adaptive skills in  
4 education, technology, applied science, agriculture, commerce, arts, social  
5 science, humanities, management and allied professional disciplines;

6 (c) produce socially mature experts in education with capabilities not  
7 to only understand educational need of Nigeria as a nation, but also to exploit  
8 existing educational infrastructure and improve on it to develop new ones;

9 (d) act as agents and catalysts for effective educational system,  
10 through post graduate training , research and innovation, for effective  
11 economic utilisation and conservation of the country's human resources;

12 (e) bring quality change in education by focusing on teacher  
13 education through teaching and learning innovations;

14 (f) collaborate with other national and international institutions  
15 involved in training, research and development of education with a view to  
16 promoting governance, leadership and management skills among educational  
17 managers;

18 (g) identify educational needs of the society with a view to finding  
19 solutions to them within the context of overall national development;

20 (h) provide and promote sound basic education training as a  
21 foundation for the development of Nigeria, taking into account indigenous  
22 culture and the need to enhance national unity;

23 (i) provide higher education and foster a systematic advancement of  
24 the science and art of teacher education;

25 (j) provide for instruction in such branches of teacher education as it  
26 may deem necessary to make provision for research advancement and  
27 dissemination of knowledge in such manner as it may determine;

28 (k) provide teachers with operational competence for teaching in pre-  
29 tertiary institutions, basic, senior secondary schools and non-formal  
30 educational institutions; and

1 (1) undertake any other activity that is appropriate for a university  
2 of education of the highest standard.

3 2.-(1) The University shall consist of;

4 (a) a Chancellor;

5 (b) a Pro-Chancellor and a Council;

6 (c) a Vice-Chancellor and a Senate;

7 (d) a Congregation;

8 (e) a Convocation;

9 (f) the campuses and colleges of the University;

10 (g) the colleges, institutes and other teaching and research units of  
11 the University;

12 (h) the persons holding the offices constituted by the First Schedule  
13 to this Act other than those mentioned in paragraphs (a) - (c);

14 (i) all graduates and undergraduates of the University; and

15 (j) all other persons who are members of the University in  
16 accordance with provisions made by Statute in that behalf.

17 (2) The First Schedule to this Act shall have effect with respect to  
18 the principal officers of the University.

19 (3) Subject to section 5, provisions shall be made by Statute with  
20 respect to the constitution of the Council, the Senate, Congregation and  
21 Convocation.

22 3.-(1) For the attainment of its objectives as specified in section 1  
23 (5), the University has powers to:

24 (a) offer courses of instruction, training and research in education  
25 and allied areas for the production of quality and skilled teachers required to  
26 teach at lower, middle and higher levels of education in Nigeria in particular  
27 and the world at large;

28 (b) establish such colleges, campuses, institutes, schools,  
29 departments and other teaching and research units within the University as  
30 may be deemed necessary or desirable subject to the approval of National

1 Universities Commission;

2 (c) institute professorships, readerships, associate professorships,  
3 lectureships, and other posts and offices and to make appointments to those  
4 post and offices;

5 (d) institute and award fellowships, scholarships, exhibitions,  
6 bursaries, medals, prizes and other titles, distinctions, awards and forms of  
7 assistance;

8 (e) provide for the discipline and welfare of members of the  
9 University;

10 (f) hold examinations and grant degrees, diplomas, certificates and  
11 other distinctions to persons who have pursued a course of study approved by  
12 the University and have satisfied such other requirements as the University  
13 may lay down;

14 (g) grant honorary degrees, fellowships or academic titles;

15 (h) demand and receive from any student or any other person  
16 attending the University for the purposes of instruction, such fees as the  
17 University may determine subject to the overall directives of the Minister;

18 (i) subject to section 20, acquire, hold, grant, charge or otherwise deal  
19 with or dispose of movable and immovable property wherever it is situate;

20 (j) accept gifts, legacies and donations, but without obligation to  
21 accept the same for a particular purpose unless it approves the terms and  
22 conditions attached;

23 (k) enter into contracts, establish trusts, act as trustee, solely or jointly  
24 with any other person, and employ or act through agents;

25 (l) erect, provide, equip and maintain libraries, laboratories,  
26 workshops, lecture halls, halls of residence, refectories, sports grounds,  
27 playing fields and other buildings or things necessary, suitable or convenient  
28 for any of the objects of the University;

29 (m) hold public lectures and to undertake printing, publishing and  
30 book selling;

1 (n) subject to any limitation or condition imposed by the Statute, to  
2 invest money appertaining to the University by way of endowment, not  
3 being immediately required for current expenditure in any investment or  
4 security or in the purchase or improvement of land, with power, from time to  
5 time, to vary such investments and deposit any money for the time being not  
6 invested with any bank in a deposit or current account;

7 (o) borrow, whether on interest or not and if need be upon the  
8 security of any or all of the property, movable or immovable, of the  
9 University, such money as the Council may find necessary or expedient to  
10 borrow or to guarantee any loan, advances or credit facilities;

11 (p) make gifts for any charitable purpose;

12 (q) do anything which it is authorised or required by this Act or any  
13 Statute to do; and

14 (r) do all such acts or things, whether or not incidental to these  
15 powers, as may advance the objects of the University.

16 (2) Subject to the provisions of this Act and of the Statutes and  
17 without prejudice to section 7 (2), the powers conferred on the University  
18 under subsection (1) is exercisable on behalf of the University by the  
19 Council, Senate or in any other manner which may be authorised by the  
20 Statute.

21 (3) The power of the University to establish additional campuses  
22 and colleges within the University shall be exercised in accordance with the  
23 Statute.

24 4.-(1) The Chancellor shall, in relation to the University, take  
25 precedence before all other members of the University and, when he is  
26 present, shall preside at all meetings of Convocation held for conferring  
27 degrees.

28 (2) The Pro-Chancellor shall, in relation to the University, take  
29 precedence before all other members of the University, except the  
30 Chancellor and Vice-Chancellor when acting as Chairman of Congregation

1 or Convocation, and the Pro-Chancellor shall, when he is present, be the  
2 Chairman at all meetings of the Council.

Establishment,

of the Council

3 5.-(1) There is established for the university a Governing Council (in  
4 this Act referred to as "the Council").

5 (2) The Council shall consist of:

6 (a) the Pro-Chancellor who is appointed by the President on the  
7 recommendation of the Minister;

8 (b) the Vice-Chancellor;

9 (c) the Deputy Vice-Chancellors;

10 (d) one person from the Federal Ministry responsible for education;

11 (e) four persons representing a variety of interests and broadly  
12 representative of the whole Federation to be appointed from:

13 (i) the Teacher's Registration Council,

14 (ii) Tertiary Education Trust Fund, and

15 (iii) two other persons, one of whom shall be a representative of the  
16 University host community;

17 (f) four persons appointed by the Senate from among its members;

18 (g) two persons appointed by Congregation from among its members;

19 (h) one person appointed by Convocation from among its members;

20 and

21 (i) two persons representing the community appointed by the  
22 President.

23 (2) Persons to be appointed to the Council shall be of proven integrity,  
24 knowledgeable and familiar with the affairs and tradition of the University.

25 (3) The Council shall have a tenure of four years from the date of its  
26 inauguration but where the Council is found to be incompetent and corrupt, it  
27 shall be dissolved by the Visitor and a new Council shall be immediately  
28 constituted for the effective functioning of the University.

29 (4) The powers of the Council shall be exercised, as specified in this  
30 Act and, to that extent, establishment circulars that are inconsistent with this



1 Act shall not apply to the University.

2 (5) The Council shall be free in the performance of its functions  
3 and discharge of its responsibilities for the good management, growth and  
4 development of the University.

5 (6) The Council, in the performance of its functions, shall ensure  
6 that disbursement of funds of the University complies with the approved  
7 budgetary ratio for:

8 (a) personnel cost;

9 (b) overhead cost;

10 (c) research and development;

11 (d) library developments; and

12 (e) the balance in expenditure between academic and non-  
13 academic activities.

14 6.-(1) Subject to the provisions of this Act relating to the Visitor,  
15 the Council is:

16 (a) the governing body of the University; and

17 (b) responsible for the general control and superintendence of the  
18 policy, finances and property of the University.

19 (2) There shall be the Finance and General Purposes Committee  
20 which shall, subject to the directions of the Council:

21 (a) exercise control over the property and expenditure of the  
22 University; and

23 (b) perform such other functions of the Council as the Council may  
24 delegate to it.

25 (3) Provisions shall be made by the Statute with respect to the  
26 constitution of the Finance and General Purposes Committee.

27 (4) The Council shall ensure that proper accounts of the University  
28 are kept and that the accounts of the University are audited annually by an  
29 independent firm of auditors approved by the Council and that an annual  
30 report is published by the University together with certified copies of the

1 said accounts as audited.

2 (5) Subject to this Act and the Statute, the Council and Finance and  
3 General Purposes Committee may each make rules for the purpose of  
4 performing their respective functions or of regulating their own procedure.

5 (6) Rules made under subsection (5) by the Finance and General  
6 Purposes Committee shall not come into effect unless they are approved by the  
7 Council, and where the rules made by that Committee conflict with any  
8 direction given by the Council, whether before or after the coming into effect of  
9 the rules in question, the directions of the Council prevails.

10 (7) There shall be paid to the members respectively of the Council,  
11 Finance and General Purposes Committee and any other committee set up by  
12 the Council allowances in respect of travelling and other reasonable expenses  
13 at such rates as may be fixed by the Minister.

14 (8) The Council shall meet as and when necessary for the  
15 performance of its functions under this Act and shall meet at least three times in  
16 every year.

17 (9) If requested in writing by five members of the Council, the  
18 Chairman shall, within 28 days after the receipt of such request, call a meeting  
19 of the Council.

20 (10) Any request made under subsection (9) shall specify the business  
21 to be considered at the meeting, and no business which is not so specified shall  
22 be transacted at that meeting.

23 7.-(1) Subject to subsections (3) and (4) and the provisions of this Act  
24 relating to the Visitor, it shall be the general function of the Senate to organise  
25 and control the teaching by the University, the admission of student where no  
26 other enactment provides to the contrary, and the discipline of students, and  
27 promote research at the University.

28 (2) Without prejudice to the generality of subsection (1), it shall in  
29 particular be the function of the Senate to make provision for:

30 (a) the establishment, organisation and control of campuses, colleges,

1 schools, institutes and other teaching and research units of the University  
2 and the allocation of responsibility for different branches of learning;

3 (b) the organisation and control of courses of study at the  
4 University and of the examinations held in conjunction with those courses,  
5 including the appointment of examiners, both internal and external;

6 (c) the award of degrees, and such other qualifications as may be  
7 prescribed in connection with examinations held;

8 (d) the making of recommendations to the Council with respect to  
9 the award to any person of an honorary fellowship, honorary degree or the  
10 title of professor emeritus;

11 (e) the establishment, organisation and control of halls of residence  
12 and similar institutions at the University;

13 (f) the supervision of the welfare of students at the University and  
14 the regulation of their conduct;

15 (g) the granting of fellowships, scholarships, prizes and similar  
16 awards in so far as the awards are within the control of the University; and

17 (h) determining what descriptions of dress shall be academic dress  
18 for the purposes of the University, and regulating the use of academic dress.

19 (3) The Senate shall not establish any new campus, college, school,  
20 department, institute or other teaching and research units of the University,  
21 any hall of residence or similar institution at the University without the  
22 approval of the Council.

23 (4) Subject to this Act and the Statutes, the Senate may make  
24 regulations for the purpose of performing any function conferred on it either  
25 by this section or for the purpose of making provision for any matter covered  
26 by regulations and is authorised or required by this Act or by Statute.

27 (5) Regulations shall provide that at least one of the persons  
28 appointed as the examiners at each final or professional examination held in  
29 conjunction with any course of study at the University is not a teacher at the  
30 University but is a teacher of the branch of learning to which the course

1 relates at some other University of high repute or a person engaged in  
2 practicing the profession in a reputable organisation or institution.

3 (6) Subject to right of appeal to the Council from a decision of the  
4 Senate under this subsection, the Senate may deprive any person of any degree,  
5 diploma or other award of the University which has been conferred upon him if  
6 after due enquiry the person is found to have been guilty of dishonourable or  
7 scandalous conduct in gaining admission into the University or obtaining that  
8 award.

Functions of  
the Vice-  
Chancellor

9 8.-(1) The Vice-Chancellor shall, in relation to the University, take  
10 precedence before all other members of the University except the Chancellor,  
11 and subject to section 4 except the Pro-Chancellor and any other person for the  
12 time being acting as Chairman of the Council.

13 (2) Subject to sections 6, 7 and 14, the Vice-Chancellor shall:

14 (a) have the general function, in addition to any other function  
15 conferred on him by this Act of directing the activities of the University; and

16 (b) be the Chief Executive and Accounting Officer of the University  
17 and ex-officio Chairman of the Senate.

18 (3) The Vice-Chancellor shall be the Chairman of the University  
19 Tenders' Board, which is saddled with the responsibility of approving the  
20 conduct of public procurement of goods, works and services within the  
21 approved threshold.

22 (4) It is the responsibility of the Vice-Chancellor to establish and  
23 appoint members of the Tenders' Board in line with the extant Public  
24 Procurement Rules and Regulations.

25 PART II - GENERAL FUND, TRANSFER OF PROPERTY TO THE UNIVERSITY  
26 AND CONDITIONS OF SERVICE OF EMPLOYEES

General Fund  
of the University

27 9.-(1) There shall be a general fund of the University (in this Act  
28 referred to as "the General Fund") which shall consist of:

29 (a) grants-in-aid;

30 (b) fees;

- 1 (c) income derived from investments;
- 2 (d) gifts, legacies, endowments and donations not accepted for a  
3 particular purpose;
- 4 (e) income derived from the performance of any functions  
5 conferred or imposed on the University by this Act;
- 6 (f) any other amount, charges or dues recoverable by the  
7 University;
- 8 (g) revenue accruing to the University by way of subvention;
- 9 (h) interests on investments;
- 10 (i) donations and legacies accruing to the University from any  
11 source for the general or special purposes of the University; and
- 12 (j) Tertiary Trust Fund (TETFUND) interventions;
- 13 (2) The General Fund shall be applied for the purposes of the  
14 University.

15 10.-(1) All property held by, or on behalf of the Provisional Council  
16 of the University shall, by virtue of this subsection, vest in the University  
17 and be held by it for the purpose of the University.

18 (2) The provisions of the Second Schedule to this Act shall have  
19 effect with respect to, and to matters arising from:

- 20 (a) the transfer of property by this section; and
- 21 (b) other matters mentioned in that Schedule.

22 PART III - STATUTES OF THE UNIVERSITY

23 11.-(1) Subject to this Act, the University may make Statutes for:

Power of the

- 24 (a) making provision with respect to the composition and  
25 constitution of any authority of the University;
- 26 (b) specifying and regulating the powers and duties of any  
27 authority of the University, and regulating any other matter connected with  
28 the University or any of its authorities;
- 29 (c) regulating the admission of students where no other enactment  
30 provides to the contrary, and their discipline and welfare;

1 (d) determining whether any particular matter is to be treated as an  
2 academic or non-academic matter for the purposes of this Act and any Statute,  
3 regulation or other instrument made under this Act; or

4 (e) making provision for any other matter which is authorised or  
5 required by this Act.

6 (2) Subject to section 25 (6), the Interpretation Act applies in relation  
7 to any Statute made under this section as it applies to a subsidiary instrument  
8 within the meaning of section 28 (1).

Third Schedule

9 (3) The Statute contained in the Third Schedule to this Act is deemed  
10 to have come into effect on the commencement of this Act and is deemed to  
11 have been made under this section by the University.

Third Schedule

12 (4) The power to make Statutes conferred by this section shall not be  
13 prejudiced or limited in any way by reason of the inclusion or omission of any  
14 matter in or from the Statute contained in the Third Schedule to this Act or any  
15 subsequent Statute.

Mode of exercising  
power to make  
Statutes

16 12.-(1) The power of the University to make Statutes shall be  
17 exercised in accordance with the provisions of this section.

18 (2) A proposed Statute shall not become law unless it has been  
19 approved at the meeting of the:

20 (a) Senate, by the votes of at least two-thirds of the members present  
21 and voting; and

22 (b) Council, by the votes of at least two-thirds of the members present  
23 and voting.

24 (3) A proposed Statute may originate either in the Senate or Council,  
25 and may be approved as required by subsection (2).

26 (4) A Statute which:

27 (a) makes a provision for or alters the composition or constitution of  
28 the Council, the Senate or any other authority of the University, or

29 (b) provides for the establishment of a new campus or college or for  
30 the amendment or revocation of any statute,

1 shall not come into effect unless it has been approved by the Visitor.

2 (5) For the purpose of section 2 (2) of the Interpretation Act, a  
3 Statute shall be treated as being made on the date on which it is duly  
4 approved by the Council or Senate, in accordance with subsection (2) or in  
5 the case of a Statute falling within subsection (4), on the date on which it is  
6 approved by the President.

7 (6) In the event of any doubt or dispute arising at any time as to:

8 (a) the meaning of any provision of a Statute, or

9 (b) whether any matter is, for the purposes of this Act, an academic  
10 or non-academic matter as it relates to such doubt or dispute,  
11 the matter may be referred to the Visitor, who shall take such advice and  
12 make such decision as he may think fit.

13 (7) The decision of the Visitor on any matter referred to him under  
14 subsection (6) is binding upon the authorities, staff, and students of the  
15 University, and where any question as to the meaning of any provision of a  
16 Statute has been decided by the Visitor under that subsection, no question as  
17 to the meaning of that provision shall be entertained by any court of law in  
18 Nigeria.

19 (8) Nothing in subsection (7) affects any power of a court of  
20 competent jurisdiction to determine whether any provision of a Statute is  
21 wholly or partly void as being ultra vires or as being inconsistent with the  
22 Constitution of the Federal Republic of Nigeria.

23 13. A Statute may be proved in any court by the production of a  
24 copy bearing or having affixed to it a certificate purporting to be signed by  
25 the Vice-Chancellor or the Secretary to the Council to the effect that the copy  
26 is a true copy of a Statute of the University.

27 PART IV - SUPERVISION AND DISCIPLINE

28 14.-(1) The President shall be the Visitor of the University.

The Visitor

29 (2) The Visitor shall cause a visitation to the University when  
30 necessary, at least every five years, or direct that such a visitation be

1 conducted by such person or persons as the Visitor may deem fit and in respect  
2 of any of the affairs of the University.

3 (3) It is the duty of the bodies and persons comprising the University  
4 to make available to the Visitor and any other person conducting a visitation  
5 under this section, such facilities and assistance as the visitor or that person  
6 may reasonably require for the purposes of a visitation.

7 (4) The Visitor shall make the report of such visitations and issue a  
8 white paper to that effect and make it available to the Council for  
9 implementation.

Removal of  
certain members  
of Council

10 15.-(1) If it appears to the Council that a member of the Council, other  
11 than the Pro-Chancellor or the Vice-Chancellor should be removed from office  
12 on the ground of misconduct or inability to perform the functions of his office  
13 or employment, the Council shall make a recommendation to that effect  
14 through the Minister, to the Visitor, and the Visitor, after making such inquiries  
15 as he may consider appropriate, if he approves the recommendation, may direct  
16 the removal of the person in question from office.

17 (2) The Minister shall cause a copy of the instrument embodying a  
18 direction under subsection (1) to be served, as soon as reasonably practicable,  
19 on the person to whom it relates.

Removal and

20 16.-(1) If it appears to the Council that there are reasons for believing  
21 that any person employed as a member of the academic, administrative or  
22 professional staff of the University, other than the Vice-Chancellor, should be  
23 removed from his office or employment on the ground of misconduct or  
24 professional inability to perform the functions of his office or employment, the  
25 Council shall:

- 26 (a) give notice of those reasons to the person in question;  
27 (b) afford him an opportunity of making representations in person on  
28 the matter by the Council; and  
29 (c) afford the person in question, an opportunity of appearing before  
30 and being heard by the investigating committee with respect to the matter.



1           (2) If the Council, after considering the report of the investigating  
2 committee, is satisfied that the person in question should be removed, the  
3 Council may so remove him by an instrument in writing signed on the  
4 directions of the Council.

5           (3) The Vice-Chancellor may, in a case of misconduct by a member  
6 of staff which, in the opinion of the Vice-Chancellor is prejudicial to the  
7 interest of the University, suspend such member and the suspension shall  
8 immediately be reported to the Council.

9           (4) For good cause, any member of staff may be suspended from  
10 his duties, or his appointment may be terminated by the Council, and for the  
11 purposes of this subsection, "good cause" means:

12           (a) conviction for any offence which the Council considers to be  
13 such as to render the person concerned unfit for the discharge of the duties of  
14 his office;

15           (b) any physical or mental incapacity which the Council, after  
16 obtaining medical advice, considers to be such as to render the person  
17 concerned unfit to continue to hold his office;

(i) the qualities of the persons who may apply for the post, and

(ii) the terms of conditions of service applicable to the post, and thereafter draw up a short list of suitable candidates for the post for consideration; and

(b) constitute a Search Team consisting of:

(i) a member of the Council, who is not a member of the Senate, as Chairman,

(ii) two members of the Senate who are not members of the Council, one of whom shall be a Professor,

(iii) two members of Congregation who are not members of the Council, one of whom shall be a Professor,

to identify and nominate for consideration, suitable persons who are not likely to apply for the post on their own volition because they felt that it is not proper to do so.

(3) A Joint Council and Senate Selection Board consisting of:

(a) the Pro-Chancellor, as chairman,

(b) two members of the Council, not being members of the Senate,

(c) two members of the Senate who are Professors, but who were not members of the Search Team,

shall consider the candidates and persons in the shortlist drawn up under subparagraph (2) (a) (ii) of this paragraph through an examination of their curriculum vitae and interaction with them, and recommend to the Council

1 three candidates for further consideration.

2 (4) The Council shall select and appoint as the Vice-Chancellor one  
3 candidate from among the three candidates recommended to it under  
4 subparagraph (3) of this paragraph and thereafter inform the Visitor.

5 (5) The Vice-Chancellor shall hold office for a single term of five  
6 years only on such terms and conditions as may be specified in his letter of

10 each list forwarded to it under subparagraph (2) of this paragraph and

14 (b) act in the place of the Vice-Chancellor when the post of the

## TRANSITIONAL PROVISIONS AS TO PROPERTY, FUNCTIONS, ETC.

*Transfer of Property to University*

## 1. Without prejudice to section 10(1) of this Act:

(a) the reference to property held by the Provisional Council includes

a reference to the right to receive and give a good discharge for any grant or contribution which may have been voted or promised to the Provisional Council; and

(b) all debts and liabilities of the Provisional Council outstanding

shall become debts or liabilities of the University.

2.-(1) All agreements, contracts, deeds and other instruments to which the Provisional Council was a party shall, so far as possible and subject to any necessary modification, have effect as if the University had been a party thereto in place of the Provisional Council.

(2) Documents not falling within subparagraph (1) of this paragraph, including enactment which refer, whether specially or generally, to the Provisional Council, shall be construed in accordance with that subparagraph so far as applicable.

(3) Any legal proceedings or application to any authority pending by or against the Provisional Council may be continued by or against the University.

*Registration of transfers*

3.-(1) If the law in force at the place where any property transferred by this Act is situate provides for the registration of transfers of property of the kind in question (whether by reference to an instrument of transfer or otherwise), the law shall, so far as it provides for alterations of a register (but not for avoidance of transfers, the payment of fees or any other matter) apply, with necessary modifications, to the property.

(2) The body to which any property is transferred by this Act shall



1 furnish the necessary particulars of the transfer to the proper officer of the  
2 registration authority, and of that officer to register the transfer accordingly.

3 *Transfer of Functions, etc.*

4 4.-(1) The first meeting of the Council shall be convened by the  
5 Pro-Chancellor on such date and in such manner as he may determine.

6 (2) The persons who are members of the Provisional Council are  
7 deemed to constitute the Council until the date when the Council as set up  
8 under the Third Schedule to this Act shall have been duly constituted.

9 (3) The first meeting of the Senate as constituted by this Act shall  
10 be convened by the Vice-Chancellor on such date and in such manner as he  
11 may determine.

12 (4) The persons who are members of the Academic Board  
13 immediately before the coming into effect of this Act are deemed to  
14 constitute the Senate of the University until the date when the Senate as set  
15 up under the Third Schedule to this Act shall have been duly constituted.

16 (5) Subject to any regulation which may be made by the Senate  
17 after the date on which this Act is made, the schools, school boards and  
18 students of the University immediately before the coming into effect of this  
19 Act shall on that day become schools, school boards and students of the  
20 University as constituted by this Act.

21 (6) Persons who are Deans of Schools and Heads of Academic  
22 Departments shall continue to be Deans or Heads of Department of the  
23 corresponding School and Department, until new appointments are made  
24 under the Statutes.

25 (7) Any person who was a member of the staff of the University as  
26 established or was employed by the Provisional Council becomes the holder  
27 of an appointment at the University with the status, designation and  
28 functions which correspond as nearly as may be to those which appertained  
29 to him as member of that staff or as such an employee.

*Article*

1. The Council.

*The Council*

- 1.-(1) The composition of the Council shall be as provided in section 5 of this Act.
- (2) Any member of the Council holding office other than under

1 section 5 (2) (a), (b), (c), or (d) of this Act may, by notice to the Council,  
2 resign his office.

3 (3) A member of the Council holding office other than under  
4 section 5 (2) (a), (b), (c), or (d) of this Act shall, unless he previously vacates  
5 it, vacate that office on the expiration of the period of four years beginning  
6 with effect from 1 August of the year which he was appointed.

7 (4) Where a member of the Council holding office other than under  
8 section 5 (2) (a), (b), (g), or (h) of this Act vacates office before the  
9 expiration of the period mentioned, the body or person by whom he was  
10 appointed may appoint a successor to hold office for the residue of the term  
11 of his predecessor.

12 (5) A person ceasing to hold office as a member of the Council  
13 other than by removal for misconduct shall be eligible for re-appointment  
14 for only one further period of four years.

15 (6) The quorum of the Council is five, at least one of whom shall be  
16 a member appointed under section 5 (2) (d) or (e) of this Act.

17 (7) If the Pro-Chancellor is not present at a meeting of the Council,  
18 such other member of the Council present at the meeting as the Council may  
19 appoint for that meeting shall be the Chairman, and subject to section 4 of  
20 this Act and this paragraph, the Council may regulate its own procedure.

21 (8) Where the Council desires to obtain advice with respect to any  
22 particular matter, it may co-opt not more than two persons for that purpose,  
23 and the persons co-opted may take part in the deliberations of the Council at  
24 the meeting but shall not be entitled to vote.

25 *The Finance and General Purposes Committee*

26 2.-(1) The Finance and General Purposes Committee of the  
27 Council shall consist of:

28 (a) the Pro-Chancellor, who shall be the chairman of the  
29 Committee at any meeting at which he is present;

30 (b) the Vice-Chancellor and Deputy Vice-Chancellors;

1 (c) six other members of the Council appointed by the Council, two of  
2 whom shall be selected from among the four members of the Council  
3 appointed by the Senate and one member appointed to the Council by  
4 Congregation; and  
5 (d) the Permanent Secretary of the Federal Ministry of Education, or  
6 his representative.  
7 (2) The quorum of the Committee is five.  
8 (3) Subject to a directions given by the Council, the Committee may  
9 regulate its own procedure.  
10 *Annual budget and estimates, etc.*  
11 3.-(1) The estimates of income and expenditure for a financial year  
12 shall be presented by the Vice-Chancellor to the Council and may be approved  
13 by the Council before the beginning of that financial year:  
14 Provided that the Vice-Chancellor may during any financial year,  
15 present, and the Council may approve supplementary estimates of income or  
16 expenditure.  
17 (2) The annual and supplementary estimates shall be prepared in such  
18 form and shall contain such information as the Council may direct.  
19 *Gifts, donations, etc.*  
20 4.-(1) The Council may on behalf of the University accept by way of  
21 grants, gift, testamentary disposition or otherwise, property and money in aid  
22 of the finances of the University on such conditions as it may approve.  
23 (2) Registers shall be kept of all donations to the University, including  
24 the names of donors and any special conditions under which the donation may  
25 have been given:  
26 Provided that the University shall not be obliged to accept a donation  
27 for a particular purpose unless it approves of the terms and conditions attaching  
28 to such donation.  
29 (3) All property, money or funds donated for any specific purposes  
30 shall be applied and administered in accordance with the purposes for which

1 they are donated and shall be accounted for separately.  
2 (4) All sums of money received on account of the University shall  
3 be paid into bank account as may be approved by the Council for the credit of  
4 the University's general, current or deposit account:

5 Provided that the Council may invest, as it deems fit, any money  
6 not required for immediate use other than donations of money referred to in  
7 sub article (1) of this article.

8 (5) The Council shall cause the accounts of the University to be  
9 audited by auditors appointed by the Council as soon as may be practicable  
10 after the end of each financial year or for any such other period as the  
11 Council may require.

12 (6) The appointment and other matters relative to the auditors, their  
13 continuance in office and their functions, as the case may be, shall, subject to  
14 the provisions of this section, be prescribed by Statute.

*The Senate*

15 5.-(1)The Senate shall consist of:

- 16 (a) the Vice-Chancellor;
- 17 (b) Deputy Vice-Chancellors;
- 18 (c) the Deans of respective Colleges;
- 19 (d) the Professors in the University;
- 20 (e) Heads of Academic Departments and Units;
- 21 (f) the University Librarian;
- 22 (g) One elected representative of each College;
- 23 (h) Two members of Academic Staff elected by the Congregation;
- 24 (i) One elected representative of each department;
- 25 (j) Two members representing a variety of interests of the
- 26 professional bodies outside the University appointed by the Senate on the
- 27 recommendation of the Vice-Chancellor; and
- 28 (k) Registrar who shall be the Secretary.

29 (2)The procedure for election of members of Senate to the Council  
30

1 shall be prescribed by regulations.

2 (3) The Vice-Chancellor shall be the chairman at all meetings of the  
3 Senate when he is present, and, in his absence any of the Deputy Vice-  
4 Chancellors present at the meeting as the Senate may appoint for that meeting  
5 shall be the chairman at the meeting.

6 (4) The quorum of the Senate shall be one quarter or the nearest whole  
7 number less than one quarter; and subject to sub article (3) of this article, the  
8 Senate may regulate its own procedure.

9 (5) An elected member may, by notice to the Senate, resign his office.

10 (6) Subject to sub article (8) of this article, there shall be elections for  
11 the selection of elected members, which shall be held in the prescribed manner  
12 on such day in the month of May or June in each year as the Vice-Chancellor  
13 may determine.

14 (7) An elected member shall hold office for the term of two years  
15 beginning with 1 August in the year of his election, and may be a candidate at  
16 any election held under sub article (6) of this article in the year in which his  
17 term of office expires, and no person shall be a candidate if at the end of his  
18 current term of office the person will have held office as an elected member for  
19 a continuous term of six years or may have so held office if he had not resigned  
20 it.

21 (8) No election shall be held under this article in any year if the  
22 number specified in the certificate given under sub article (11) of this article  
23 does not exceed by more than one the figure which is thrice the number of those  
24 elected members holding office on the date of the certificate who do not vacate  
25 office during that year under sub article (7) of this article.

26 (9) A person shall not be precluded from continuing in or taking office  
27 as an elected member by reason only of reduction in the after 30 April in any  
28 year in which he is to continue in or take office as all elected member.

29 (10) If so requested in writing by any 15 members of the Senate, the  
30 Vice-Chancellor or in his absence any of the Deputy Vice-Chancellor duly

1 appointed by him, shall convene a meeting of the Senate to be held not later  
2 than the 10th day following date which the request was received.

3 (11) In this article "total of non-elected members" means as respect  
4 any year, such number as may be certified by the Vice-Chancellor on 30  
5 April of that year to be the number of persons holding office as members of  
6 the Senate on that day other than elected members.

7 *Congregation*

8 6.-(1) The Congregation shall consist of:

9 (a) Vice-Chancellor;

10 (b) the Deputy Vice-Chancellors;

11 (c) the full-time members of the academic staff;

12 (d) the Registrar;

13 (e) the Librarian; and

14 (f) every member of the administrative staff who holds a degree,  
15 other than honorary degree, of any University recognised for the purposes of  
16 this Statute by the Vice-Chancellor.

17 (2) Subject to section 4 of this Act, the Vice-Chancellor shall be the  
18 Chairman at all meetings of the Congregation when he is present, and, in his  
19 absence, any of the Deputy Vice-Chancellors present at the meeting as  
20 Congregation may appoint for that meeting, shall be the Chairman at the  
21 meeting.

22 (3) The quorum of Congregation is one-third or the whole number  
23 nearest to one-third of the total number of members of Congregation of 50,  
24 whichever is less.

25 (4) A certificate signed by the Vice-Chancellor specifying the:

26 (a) total number of members of Congregation for the purpose of  
27 any particular meeting or meetings of Congregation, or

28 (b) names of the persons who are members of Congregation during  
29 a particular period,

30 shall be conclusive evidence of that number or, as the case may be, of the

1 names of those persons.

2 (5) The procedure for election of members of Congregation to the  
3 Council and the Senate shall be prescribed by regulations.

4 (6) Subject to this article, Congregation may regulate its own  
5 procedure.

6 (7) Congregation is entitled to express by resolutions its opinion on all  
7 matters affecting the interest and welfare of the University and shall have such  
8 other functions, in addition to the function of electing a member of the Council,  
9 as may be provided by Statute or regulations.

10 *Convocation*

11 7.-(1) Convocation shall consist of:

12 (a) the officers of the University mentioned in the First Schedule to  
13 this Act;

14 (b) all teachers within the meaning of this Act; and

15 (c) all other persons whose names are registered in accordance with  
16 subarticle (2) of this article.

17 (2) A person shall be entitled to have his name registered as a member  
18 of Convocation if he:

19 (a) is either a graduate of a University or a person satisfying such  
20 requirements as may be prescribed for the purposes of this paragraph; and

21 (b) applies for the registration of his name in the prescribed manner  
22 and pay the prescribed fees.

23 (3) Regulations shall provide for the establishment and maintenance  
24 of a register for the purpose of this article and subject to subarticle (4) of this  
25 article may provide for the payment of further fees by persons whose names are  
26 on the register and for the removal from the register of the name of any person  
27 who fails to pay those fees.

28 (4) The person responsible for maintaining the register shall, without  
29 the payment of any fees, ensure that the names of all persons who are for the  
30 time being members of the Convocation by virtue of subarticle (1) (a) or (b) of



1 this article are entered and retained on the register.

2 (5) A person who reasonably claims that he is entitled to have his  
3 name on the register is entitled on demand to inspect the register or a copy of  
4 the register at the principal office of the University at all reasonable times.

5 (6) The register is, unless the contrary is proved, be sufficient  
6 evidence that any person named therein is, a member of Convocation, but  
7 for the purpose of ascertaining whether a particular person was such a  
8 member on a particular date, any entries in and deletions from the register  
9 made on or after that date shall be disregarded.

10 (7) The quorum of Convocation is 50 or one-third or the whole  
11 number nearest to one-third of the total number of members of Convocation  
12 whichever is less.

13 (8) Subject to section 4 of the Act, the Chancellor shall be  
14 Chairman at all meetings of Convocation when he is present, and in his  
15 absence the Vice-Chancellor shall be the Chairman at the meeting.

16 (9) Convocation shall have such functions, in addition to the  
17 function of appointing a member of the Council, as may be provided by  
18 Statute or regulations.

#### 19 *Division of Colleges*

20 8. Each College shall be divided into such number of branches as  
21 may be prescribed.

#### 22 *College Boards*

23 9.-(1) There shall be established in respect of each College, a Board  
24 of Studies which, subject to the provisions of this Statute, and the directions  
25 of the Vice-Chancellor, shall:

26 (a) regulate the teaching and study of, and the conduct of  
27 examinations connected with, the subjects assigned to the college;

28 (b) deal with any other matter assigned to it by Statute, Vice-  
29 Chancellor or Senate; and

30 (c) advise the Vice-Chancellor or Senate on any matter referred to

1 it by the Vice-Chancellor or Senate.

2 (2) Each College Board of Studies shall consist of:

3 (a) the Vice-Chancellor;

4 (b) the Dean;

5 (c) the persons severally in charge of the branches of the school;

6 (d) the College examination officer;

7 (e) such number of teachers assigned to the College and having the  
8 prescribed qualifications as the Board may determine; and

9 (f) such persons, whether or not members of the University, as the  
10 Board may determine with the general or special approval of the Senate.

11 (3) The quorum of the Board shall be eight members or one quarter,  
12 whichever is greater, of the members for the time being of the board, and  
13 subject to the provisions of this Statute and to any provision made by  
14 regulations in that behalf, the Board may regulate its own procedure.

15 *Deans of the Colleges*

16 10.-(1) The Board of each College shall, at a last meeting of any  
17 academic year which the term of office of the Dean expires, nominate one of its  
18 members, being one of the Professors assigned to that teaching unit, for  
19 appointment by the Senate as Dean of the College

20 (2) The person appointed under subarticle (1) of this article shall act as  
21 Dean of the College and Chairman of all meetings of the College Board when  
22 he is present and shall be a member of all committees and other boards  
23 appointed by the College.

24 (3) The Dean shall hold office for two years and shall be eligible for  
25 re-appointment one further term of two years, and shall not be eligible for re-  
26 appointment until two years have elapsed.

27 (4) The Dean of a College shall exercise general superintendence over  
28 the academic and administrative affairs of the College.

29 (5) The Dean shall present to Convocation for the conferment of  
30 degrees to persons who have qualified for the degrees of the University at

1 examination held in the branches of learning for which responsibility is  
2 allocated to that College.

3 (6) There shall be a committee to be known as the Committee of  
4 Deans consisting of all the Deans of the several Colleges and that  
5 Committee shall advise the Vice-Chancellor on all academic matters and on  
6 particular matters referred to the University by the Senate.

7 (7) The Dean of a College may be removed from office for good  
8 cause by the College Board after a vote have been taken at a meeting of the  
9 Board, and in the event of a vacancy occurring due to the removal of a Dean,  
10 an acting Dean may be appointed by the Vice-Chancellor.

11 Provided that at the next College Board meeting, an election shall  
12 be held for a new Dean.

13 (8) In this article "good cause" has the same meaning, as in section  
14 16(4) of the Act.

#### 15 *Departmental Board of Studies*

16 11.-(1) There shall be a Departmental Board of Studies whose  
17 membership shall be made of all academic staff of the Department.

18 (2) The Departmental Board of Studies shall be headed by a  
19 Professor who shall be appointed by the Vice Chancellor and in the absence  
20 of a Professor, a senior academic staff shall be appointed in acting capacity.

21 (3) The tenure of office for a Professor heading the Department of  
22 Board of Studies is three years and one year for the person appointed in  
23 acting capacity.

24 (4) The Departmental Board of Studies shall:

25 (a) superintend over all teachings and examinations in the  
26 department;

27 (b) handle all disciplinary matters in the department and make  
28 recommendations to the College where necessary; and

29 (c) allocate courses in the department on the recommendation of  
30 the Head of Department.

1 *Selection of Directors of Physical Planning and Development*

2 *Works, Services and Health*

3 12.-(1) When a vacancy occurs in the office of the Directors of  
4 Physical Planning and Development, Works and Services and Health, a  
5 Selection Board shall be constituted by the Council which shall consist of:

6 (a) the Pro-Chancellor;

7 (b) the Vice-Chancellor;

8 (c) two members appointed by the Council, not being members of the  
9 Senate; and

10 (d) two members appointed by the Senate.

11 (2) The Selection Board after making inquiries as it deems fit, shall  
12 recommend a candidate to the Council for appointment to the vacant office,  
13 and after considering the recommendation of the Selection Board the Council  
14 may make an appointment to that office.

15 *Tenure of Directors*

16 13. A Director shall hold office on such terms and conditions as may  
17 be specified in his letter of appointment subject to the extant regulations.

18 *Creation of Academic Posts*

19 14. Recommendations for the creation of academic posts other than  
20 principal officers shall be made by the Senate to the Council through the  
21 Finance and General Purposes Committee.

22 *Appointment of Academic Staff*

23 15.-(1) Subject to this Act and Statutes, the filling of vacancies in  
24 academic posts (including newly created ones) shall be the responsibility of the  
25 Council through the Departments and Colleges.

26 (2) For the purpose of filling such vacancies, suitable Selection  
27 Boards to select and make appointments on behalf of the Council shall be set  
28 up.

29 (3) For appointment to Professorships, Associate Professorship,  
30 Readerships or equivalent posts, a Selection Board, with power to appoint,

1 shall consist of:

2 (a) the Vice-Chancellor who shall be the Chairman;

3 (b) Deputy Vice-Chancellor;

4 (c) the Dean of the College;

5 (d) Head of Department;

6 (e) Registrar who shall be the Secretary; and

7 (f) such other persons, not exceeding two in number, deemed  
8 capable of helping the Board in assessing both the professional and  
9 academic suitability of a candidate under consideration, as the Senate may  
10 appoint.

11 (4) For other academic posts, a Selection Board, with power to  
12 appoint, shall consist of:

13 (a) the Vice-Chancellor or his representative who shall be the  
14 Chairman;

15 (b) The Dean of the College;

16 (c) Head of the Department concerned;

17 (d) An internal member of Council (not below the Rank of Senior  
18 Lecturer from the sister college in the candidate's subject-area); and

19 (e) Registrar or his representative who shall be the Secretary.

20 (5) All appointments to senior library posts shall be made in the  
21 same way as equivalent appointments in the academic cadre, and for all such  
22 posts other than that of the Librarian, the Librarian shall be a member of the  
23 Selection Board.

24 (6) Selection Boards may interview candidates directly or consider  
25 the reports of specialist interviewing panels and shall in addition, in the case  
26 of Professorships, Associate Professorship, Readerships or equivalent  
27 Posts, consider the reports of external assessors relevant to the area in which  
28 the appointment is being considered and the Quorum is three members  
29 including the Chairman.
