The objects of the University shall be to: Objects of the University 10 (a) encourage the advancement of learning and to hold out to all 11 persons without distinction of race, creed, sex or political conviction the 12 opportunity of acquiring tertiary education in Agriculture; 13 (b) to develop and offer academic and professional programmes 14 leading to the award of diplomas, first degrees, post-graduate research and 15 higher degrees with emphasis on Agricultural research, planning, adaptive, 16 technical, maintenance, developmental and productive skills in the 17 engineering, scientific, and allied professional disciplines with the aim of 18 producing socially mature men and women with capability not only to 19 understand, use and adapt existing technologies in the Agriculture, but also 20 to improve on them and develop new ones;

(c) to act as agents and catalysts, through post-graduate training,

	10	(f) to identify the problems and needs of the Agriculture sector in
	11	Nigeria and to find solutions to them within the context of overall national

	14	foundation for the development of Agriculture in Nigeria, taking into account
	15	indigenous cultures and the need to enhance national unity;
	16	(h) to encourage and promote scholarship and conduct research in

	18	(i) to relate its activities to the technological, social, cultural and
	19	economic needs of the people of Nigeria; and

12	(i) accept gifts, legacies and donations, but without obligation to
13	accept the same for a particular purpose unless it approves the terms and
14	conditions attaching thereto;
15	(j) enter into contracts, establish trusts, act as trustee, solely or jointly
16	with any other person, and employ and act through agents;
17	(k) erect, provide, equip and maintain libraries, laboratories, lecture
18	halls, halls of residence, refectories, sports grounds, playing fields and other
19	buildings or things necessary, suitable or convenient for any of the objects of
20	the University;
21	(l) hold public lectures and undertake printing, publishing and book
22	selling;
23	(m) subject to any limitations or conditions imposed by Statute, to
24	invest any moneys appertaining to the University by law of endorsement,
25	whether for general or special purposes, and such other moneys as may not be
26	immediately required for current expenditure, in any investments or securities
27	or in the purchase or improvement of land, with power from time to time to vary
28	any such investments and to deposit any moneys for the time being un-invested
29	with any bank on deposit or current account;

8	(d) making of recommendations to the Council with respect to the
9	award to any person of an honorary fellowship or honorary degree or the title of
10	professor emeritus;
11	(e) establishment, organization and control of halls of residence and
12	similar institutions in the University;
13	(f) supervision of the welfare of students in the University and the
14	regulation of the conduct;
15	(g) granting of fellowships, scholarships, prizes and similar awards in
16	so far as the awards are within the control of the University; and
17	(h) determination of what description of dress shall be academic dress
18	for the purpose of the University, and regulating the use of academic dress.
19	(3) The Senate shall not establish any new campus, college, faculty,
20	department school, institute or other teaching and research units of the
21	University, or any hall of residence or similar institution at the University
22	without the approval of the Council.
23	(4) (a) Subject to this Act and the Statutes, the Senate may make
24	regulations for the purpose of exercising any function conferred on it either by
25	the provisions of this section or for the purpose of providing for any matter for
26	which provision by regulation is authorized or required by this Act or by
27	Statute;
28	(b) The Senate shall, by regulation, provide that at least one of the
29	persons appointed as examiners at each final or professional examination held
30	in conjunction with any course of study in the University is not a teacher at the

1	University but is a teacher at the branch of learning to which the course	
2	relates in some other university of high repute.	
3	(5) Subject to a right of appeal to the Council from a decision of the	
4	Senate under this subsection, the Senate may deprive any person of any	
5	degree, diploma or other award of the University which has been conferred	
6	on him if after due enquiry he is shown to have been guilty of any	
7	dishonorable or scandalous conduct in gaining admission into the	
8	University or obtaining that award.	
9	9(1) The Vice-Chancellor shall, in relation to the University, take	Functions of the
10	precedence before all other members of the University except the	Vice-Chancello
11	Chancellor and, subject to section 5 of this Act, the Pro-Chancellor and any	
12	other person for the time being acting as Chairman of the Council.	
13	(2) Subject to the provisions of this Act, the Vice-Chancellor shall	
14	have general function, in addition to any other functions conferred on him	
15	by this Act or otherwise, of directing the activities of the University, and	
16	shall to the exclusion of any other person or authority be the Chief Executive

	15	(3) The Statute contained in the Third Schedule to this Act shall be
	16	deemed to have come into force on the commencement of this Act and shall be
	17	deemed to have been made under this section by the University.
	18	(4) The power to make Statute conferred by this section shall not be
	19	prejudiced or limited in any way by reason of the inclusion or omission of any
	20	matter in or from the Statute contained in the Third Schedule to this Act or any
	21	subsequent Statute.

27	the interest of the University, suspend such member and any such
28	suspension shall immediately be reported to the Council.
29	(4) Any member of staff may be suspended from duty or his
30	appointment may be terminated by Council for a good cause and for the

purposes of this subsection "good cause" means:

2	(a) conviction for any offence which the Council considers to be such
3	as to render the person concerned unfit for the discharge of the functions of his
4	office;
5	(b) any physical or mental incapacity which the Council, after
6	obtaining medical advice, considers to be such as to render the person
7	concerned unfit to continue to hold office;
8	(c) conduct of a scandalous or disgraceful nature which the Council
9	considers to be such as to render the person concerned unfit to continue to hold
10	office; or
11	(d) conduct which the Council considers to be such as to constitute
12	failure or inability of the person concerned to discharge the functions of his
13	office or to comply with the terms and conditions of his service.
14	(5) Any person suspended pursuant to subsection (3) of this section
15	shall be on half pay and the Council shall before the expiration of a period of
16	three months from the date of such suspension consider the case against that
17	person and come to a decision as to whether to:
18	(a) continue such person's suspension and if so on what terms
19	(including the proportion of his emoluments to be paid to him);
20	(b) reinstate such person in which case the Council shall restore his
21	full emoluments with effect from the date of suspension;
22	(c) terminate the appointment of the person concerned in which case
23	such a person will not be entitled to the proportion of his emoluments withheld
24	during the period of suspension; or
25	(d) take such lesser disciplinary action against such person (including
26	the restoration of such proportion of his emoluments that might have been
