BE IT ENACTED by the National Assembly of the Federal Republic of Nigeria as follows:

1. The right of every citizen of Nigerian living outside Nigeria to
vote in elections conducted in Nigeria is hereby guaranteed and protected:
Provided that citizen is duly qualified to vote in that election under applicable laws of Nigeria.

2. Elections to be conducted under this Act outside Nigeria shall include elections which the Commission, by law, is empowered to conduct,
