AN ACT TO ESTABLISH FEDERAL COLLEGE OF EDUCATION UMUNNEOCHI, ABIA STATE, TO PROVIDE FULL-TIME COURSES TEACHING, INSTRUCTION AND TRAINING IN TECHNOLOGY, APPLIED SCIENCE, ARTS, SOCIAL SCIENCES, HUMANITIES AND MANAGEMENT AND FOR RELATED MATTERS Sponsored by Hon. Nkeiruka Onyejeocha

ENACTED by the National Assembly of the Federal Republic of Nigeria:

1.--(1) There is established the Federal College of Education Umunneochi, Abia State (Herein after referred to as "the college"). (2) The College shall be a body corporate with perpetual 3 succession and common seal and shall take power to acquire and dispose of 4 interest in movable and immovable properties. 5 (3) The College may sue and be sued in its corporate name. 6 2.-(1) The governance and direction of the college affairs shall rest 7. 19	make appointment thereof (j) Receive and make gifts;
20	(k) Enter into such contracts as may be necessary or expedients for

24	(m) Encourage and make provision for research in the college;
25	(n) Do such acts and things whether or not incidental to the
26	foregoing power as may advance the objects of the college.

	30	"Council" means the Governing Council of the college established under

1	section 2 of this Bill;
2	"Function" includes power and duties;
3	"Minister" means the minister charged with responsibility of education;
4	"Member" means a member of the council including the chairman;
5 -	"Provost" means the provost of the college established under section 10 of
6	this Bill.
7	23. This Bill may be sited as the Federal College of Education,
8	Umunneochi (Establishment) Bill, 2020.

11	SUPPLEMENTARY PROVISION RELATING TO THE COUNCIL, ETC.
12	Terms of service
13	1. There may be paid to the members of the councilor any
14	committee, other than ex officio members, such remuneration and
15	allowances as may from time to time be determined by the President.
16	2. Where a vacancy occurs in respect of the membership specified
17	in section 3, it shall be filled by the appointment of a successor to hold office
18	for the reminder of the term of office of his predecessor in office and such
19	successor shall represent the same interest as his predecessor.
20	3. The council may act notwithstanding any vacancy in its
21	membership or any defect in the appointment of a member or the absence of
22	a member.
23	Proceedings
24	4(1) The Council shall meet for the conduct of business at such
25	times, places and on such days as the chairman may appoint but shall meet
26	not less than once every four months.
27	(3) The chairman may at any time and shall at the request in writing
28	of not less than six members, convene a meeting of the council.
29	(4) Where the council desires to obtain the advice of any person on
30	any particular matter, the council may co-opt persons who are not members

ı	of the council but persons co-opted shall not be entitled to vote at a meeting of
2	the council.
3	(5) The Quorum of the Council shall be one half of the total members
4	of the Council, at least one of whom shall be a member appointed by the
5	President.
6	(6) Decisions of the Council shall be made on approval by a simple
7	majority of members.
8	Miscellaneous
9	5(1) The fixing of the seal of the college shall be authenticated by the
10	signature of the chairman, Provost and of some other members of the Council
11	authorized generally or specially by the Council to act for that purpose.
12	(2) Any contract or instrument which, if made or executed by a person
13	other than a body corporate would not be required to be under seal may be made
14	executed on behalf of the college by any person generally or specially
15	authorized to act for that purpose by the council.
16	(3) Any document purporting to be duly executed under the seal of the
17	College shall be received in evidence and shall, unless the contrary is proved,
18	be presumed to be so executed.

## EXPLANATION NOTE

This Bill seeks to establish the Federal College of Education, Umunneochi Abia State as institution to offer full-time courses leading to the awards of National Certificates of Education, Diplomas etc.
