AN ACT TO ESTABLISH THE FEDERAL EYE CENTRE AT OGBONICHA FOR THE PREVENTION AND CURE OF EYE DEFECTS AND DISEASES AND TO ESTABLISH A BOARD TO GOVERN THE CENTRE AND AN ACADEMIC COMMITTEE, TO TAKE CHARGE OF THE CENTRE'S ACADEMIC AFFAIRS AND FOR RELATED MATTERS

FOR RELATED MATTERS Sponsored by Hon. David Zacharias ſ 1 Commencement ENACTED by the National Assembly of the Federal Republic of Nigeria: 1.-(1) There is hereby established at Ogbonicha, a center by the 1 Establishment, etc, of the Federal name of the Federal Eye Centre (in this Bill referred to as "the Centre"), Eye Centre 2 which shall be a body corporate with perpetual succession and a common 3 4 seal. (2) The Centre shall be a hospital, specialising in ophthalmology, 5 with facilities for the training of ophthalmic personnel at all levels. 6 7 2.-(1) The functions of the Centre shall be to provide as part of the Functions of the Centre hospital and specialist services, services in connection with the diagnosis 8 and treatment of diseases or defects of the eye, supply of optical appliances 9 and other supplementary ophthalmic services. 10 (2) The Centre shall have power: 11 12 (a) to provide diagnostic, curative, promotive and rehabilitative ophthalmic services; 13 (b) to provide ambulatory and domiciliary ophthalmic treatment, 14 employing the services of ophthalmologists and other medical practitioners; 15 (c) to provide facilities for the clinical training of 16 17 ophthalmologists; (d) to provide facilities for the training of ophthalmic and 18

dispensing opticians, ophthalmic nurses, orthoptists and ophthalmic

	3	(e) to create facilities for research into all aspects of ophthalmology,
	4	that is to say, visual, clinical and experimental;
	5	(f) to develop new diagnostic and therapeutic ophthalmic instruments
	6	and appliances better suited to the practice of ophthalmology in Nigeria.
	7	(3) For the purposes of the discharge of its functions under the
	8	foregoing provisions of this clause, the Centre may:
	9	(a) arrange periodic conferences, seminars, study groups and like
	10	activities in ophthalmology;
	11	(b) advise the Government of the Federation or of a State on all
	12	matters relating to defects and diseases of the eye and the prevention of
	13	blindness;
	14	(c) offer such assistance to ophthalmic hospitals or units in various
	15	pacts of the Federation, as the Board may deem necessary;

	7	year and proper records in relation to those accounts and shall cause its
	8	accounts to be audited as soon as may be, after the end of the financial year to
	9	which the accounts relate by a firm of auditors appointed, as respects that year,
	10	by the Board from the list and in accordance with the guidelines supplied by the
	11	Auditor-General of the Federation.
Fees for Services	12	15. The Board may, with the approval of the Minister, prescribe the
	13	scale of fees for Services chargeable for hospital services provided by the
	14	Centre.
Power to accept gifts	15	16(1) The Centre may accept gifts of land, money or other property

	18	(2) The Board shall not accept any gift if the conditions attached by

	23	Director may, without prejudice to any other disciplinary powers conferred on

21	(7) Nothing in this clause shall affect the provisions of any	
22	enactment relating to the discipline of medical practitioners, pharmacists,

24	18(1) If it appears to the Board that there are reasons for believing	Removal and discipline of

16	his duties or his appointment may be terminated by the Board; and for the
17	purposes of this clause, "good cause" means:
18	(a) a conviction for any offence which the Board considers to be such
19	as to render the person concerned unfit for the discharge of the functions of his
20	office; or
21	(b) any physical or mental incapacity which the Board, after obtaining
22	medical advice, considers to be such as to render the person concerned unfit to
23	continue to hold his office; or
24	(c) conduct of a scandalous or other disgraceful nature which the
25	Board considers to be such as to render the person concerned unfit to continue
26	to hold his office; or
27	(d) conduct which the Board considers to be such as to constitute
28	failure or inability of the person concerned to discharge the functions of his
29	office or to comply with the terms and conditions of his service.
30	(4) Any person suspended shall, subject to sub-clause (2) and (3) of

2	period of three months after the date of such suspension, consider the case

13	(a) the Appointments and Promotions Committee, which shall:
14	(i) consist of not less than five members, including the Director,
15	who shall be the chairman of the Committee;
16	(ii) be charged with the responsibility for making

18	clinical, administrative and technical staff of the Centre and have a quorum
19	of three members;
20	(b) the Junior Staff Appointments and Promotions Committee,
21	which shall have the powers set out in clause 19 of this Bill.
22	Employees of the Centre
23	5. Subject to this Bill, the Board shall have power:
24	(a) to pay the employees of the Centre such remuneration and
25	allowances as the Board may with the approval of the Minister determine;
26	(b) to pay any person appointed to a committee of the Board such
27	remuneration (whether by way of fees or otherwise), in respect of the
28	performance of his functions under this Bill and such travelling and
29	subsistence allowances while on the business of the Board, as the Board may
30	determine;

1	(c) to establish for the employees of the Centre such superannuation
2	scheme (whether contributory or not), as the Board may determine; and
3	(d) to give loans to its employees for purposes approved by the Board.
4	Miscellaneous
5	6(1) The fixing of the seal of the Board shall be authenticated by the
6	signature of the Chairman or of some other member, authorised generally or
7	specially by the Board for that purpose.
8	(2) Any contract or instrument which, if made or executed by a person
9	not being a body corporate would not be required to be under seal, may be made
10	or executed on behalf of the Centre by any person generally or specially
11	authorised to act for that purpose by the Board or a committee of the Board.
12	(3) Any document purporting to be a document duly executed under
13	the seal of the Centre shall be received in evidence and shall, unless the
14	contrary is proved, be presumed to be so executed.
15	7. The validity of any proceedings of the Board or a committee
16	thereof, shall not be affected by any vacancy in the membership of the Board or
17	committee, or by any defect in the appointment of a member of the Board or of
18	any other person on the committee.
19	8. Any member, and any person holding office on a committee of the
20	Board, who has a personal interest in any contract or arrangement entered into
21	or proposed to be considered by the Board, shall forthwith disclose his interest
22	to the Board and shall not vote on any question relating to the contract or

25	9. The provisions of this Schedule shall apply mutatis mutandis to the
26	education committee; so however that in relation to the quorum thereof, it shall
27	be as may be determined by the education committee.

This Bill seeks to establish the Federal Eye Centre at Ogbonicha for the prevention and cure of eye defects and diseases and to establish a board to govern the centre and an academic committee, to take charge of the centre's academic affairs.
