Commencement ENACTED by the National Assembly of the Federal Republic of Nigeria as follows: Amendment of 1. The Nigerian Defence Academy Act Cap. N101 LFN (in this 1 the Nigerian Defence Academy Act Cap. N101 Bill referred to as "the Principal Act") is amended as set out in this Bill. 2 3 2. Section 1 (Status of the Academy) of the Principal Act is Amendment of Section 1 4 amended by inserting the phrase, "to establish additional campuses and", after the word "power". The said section now reads: 5 "The Nigerian Defence Academy (in this Act referred to as "the 6 Academy) shall continue to be a military institution and shall have power to 7 establish additional campuses and to award its own degrees in accordance 8 with the highest academic standard as may be prescribed by the National 9 Universities Commission". 10 3. Section 12 (Power to create Offices and Departments) the Amendment of 11 Section 12 heading of this section of the principal Act is amended by adding the word 12 "and campuses" after the word "Departments". 13 The main statement of this section is amended by introduction of 14 Further Amendment of Section 12 the phrase "and shall also have the power to make recommendations for 15 creation of additional campus of the academy to the President and 16 17 commander in chief of the armed forces of Nigeria whose approval will be needed for creation of such new campus" after the word "Academy".

1 Section 12 now reads: "Power to create offices and Departments and Campus" 2 Notwithstanding the provisions of the third Schedule to this Act, the Council 3 shall have power to create any office or department, necessary for the efficient 4 running of the Academy, and shall also have the power to recommendations for 5 creation of additional campus of the academy to the President and Commander 6 in Chief of the Armed Forces of Nigeria whose approval Shall be needed for 7 creation of such new campus. 4. Section 16 (Interpretation) of the principal Act is amended by Amendment of 8 Section 16 9 addition of the phrase "Campus" Means the campus of Nigerian Defence Academy after the Phrase "Minister" "means Minister charged with the 10 responsibility for defence matters" 11 The said section now reads: 12 13 Interpretation In this Act, unless the context otherwise requires: 14 "Academy" means the Nigerian Defence Academy established under section 1 15 of this Act; 16 17 "Council" means the Nigerian Defence Academy Council established under section 4 of this Act; 18 "Minister" means Minister charged with the responsibility for defence matters; 19 20 "Campus" Means the campus of Nigerian Defence Academy established under section 1 and 12 of this Act; 21 Citation 22 5.
