Section 4 of the Principal Act is amended by inserting a new Amendment of Section 4 of the 4 Section 4(b)(1)-(3): Principal Act 5 (i) Section 4(b): Use of National Flag and Coats of Arms in Public 6 Offices and Educational Institutions; 7 (ii) Section 4(b)(1): All public offices and educational institutions 8 in Nigeria, including Ministries, Departments and Agencies of government 9 shall display the National Flag in their premises and the Coat of Arms of the Federation in their reception areas; 11 (iii) Section 4(b)(2): No other picture or portrait of any public official shall be displayed in public offices, educational institutions or any government office as enumerated in section 4(b)(1) of this Bill; 13 14 (iv) Section 4(b)(3):- Heads of public offices and other educational institutions shall be personally held liable for a breach of Section 4(b)(2) of

- **3.-**(i) Section 10 is hereby amended by deleting the subsisting section 10 and replacing it with a new one as follows:
- Section 10: "Any person found guilty of an offence against this Act shall be liable to a fine of two hundred thousand naira only (N200,000=00) and in the case of a continuing offence to a fine of ten thousand naira (N10,000=00) for everyday or part of a day during which the offence is continued after the day on which such person is first convicted".

4. This Bill may be cited as the Flag and Coats of Arms Act (Amendment) Bill, 2020.

EXPLANATORY MEMORANDUM

This Bill seeks to provide for the hoisting of our National Flags and displaying of the Coats of Arms in our public offices and educational institutions and to halt the haphazard practice of displaying pictures and portraits of public officials in public offices in Nigeria; in order to encourage the laudable nationalist sentiments of building strong institutions rather than strong men in our public service.
