BE IT ENACTED by the National Assembly of the Federal Republic of Nigeria:

1 1.-(1) All Ministries, Departments and Agencies of Government, Bi-annual reports of Capital Projects 2 whether they receive subventions from annual budgetary provisions of of Ministries. Department and 3 government or not, shall prepare and submit to the office of the Minister, Agencies 4 Federal Ministry of Finance, bi-annual reports on all their capital projects. 5 (2) The information submitted to Federal Ministry of Finance in 6 the reports on the capital projects shall include: 7 (a) the name, description, age and location of the projects; 8 (b) the status of the projects, including sources of funding, current 9 and cumulative position of fund disbursements and the expected completion 10 date; 11 (c) that the submission be made on or before the last day of the 12 month following the quarter being reported in the report. 13 2.
