{ } Commencement.

ENACTED by the National Assembly of the Federal Republic of Nigeria as follows-

1. The Constitution of the Federal Republic of Nigeria 1999 (in this Bill referred to as "the Principal Act") is altered as set out in this Bill. Alteration of Constitution.

2. Section 213 of the Principal Act is altered by inserting after subsection (5), a new subsection "(5A)": Alteration of Section 213
 "(5A) There shall be a population census every ten years after publication by the President of a population census report in the official gazette of the government of the Federation."


3. Third Schedule, Part I, item-J of the principal Act is altered by substituting the existing subparagraph (a), with a new subparagraph "(a)"- Alteration of Third Schedule
 "(a) undertake enumeration of the population every ten years through sample survey census or otherwise."

4. This Bill may be cited as Constitution of the Federal Republic of Nigeria, (Fifth Alteration) Bill No. 52, 2022 Citation

EXPLANATORY MEMORANDUM


This Bill seeks to provide for the conduct of population census every ten years after publication by the President of a population census report
