A BILL FOR

AN ACT TO ALTER THE PROVISIONS OF THE CONSTITUTION OF THE FEDERAL REPUBLIC OF NIGERIA, 1999 TO PROVIDE FOR INDEPENDENT CANDIDACY IN PRESIDENTIAL, GOVERNORSHIP, NATIONAL ASSEMBLY, STATE HOUSES OF ASSEMBLY AND LOCAL GOVERNMENT COUNCILS ELECTIONS; AND FOR RELATED MATTERS

Commencement.

ENACTED by the National Assembly of the Federal Republic of Nigeria as follows-

1. The Constitution of the Federal Republic of Nigeria 1999 (in this Bill referred to as "the Principal Act") is altered as set out in this Bill.

Alteration of

2. Section 7 of the Principal Act is altered by inserting after subsection (4), a new subsection "(4A)" -

Alteration of section 7

"(4A) In the case of an independent candidate, the person has obtained the verified signatures of at least twenty per cent of registered voters from each of all the electoral wards in the respective local government area, for a Chairmanship candidate, and signatures of at least twenty per cent of registered voters from each of all the polling units in the respective electoral wards for a councillor:

Provided that-

- (a) a registered voter shall not sign for more than one independent candidate in respect of the same office; and
- (b) the signatures shall be verified by the relevant electoral body"
- 3. Section 65 of the Principal Act is further altered-

Alteration of section 65

- (a) in subsection (2) (b), by inserting after the last word, "party", the words, "or the person is an independent candidate";
- (b) by inserting after paragraph (b), a new paragraph "(c)" -
- "(c) in the case of an independent candidate, the person has obtained the verified signatures of at least twenty per cent of registered voters from each of the local government areas in the respective Senatorial District or Federal Constituency, as the case may be:

Provided that-

- "(a) a registered voter shall not sign for more than one independent candidate in respect of the same office; and
- (b) the signatures shall be verified by the relevant electoral body"
- 4. Section 106 of the Principal Act is further altered by: -

Alteration of section 106

(a) in subsection (2) (d), by inserting after the last word, "party", the words, "or the person is an independent candidate";

- (b) inserting, after paragraph (d), a new paragraph "(e)" -
- "(e) in the case of an independent candidate, the person has obtained the verified signatures of at least twenty per cent of registered voters from each of the wards in the State Constituency:

Provided that-

- (a) a registered voter shall not sign for more than one independent candidate in respect of the same office; and
- (b) the signatures shall be verified by the relevant electoral body"
- 5. Section 131 of the Principal Act is further altered by: -

Alteration of section 131

- (a) in subsection (2) (d), by inserting after the last word, "party", the words, "or the person is an independent candidate";
- (b) inserting after paragraph (c), a new paragraph "(cc)" -
- "(cc) in the case of an independent candidate, the person has obtained the verified signatures of at least twenty per cent of registered voters from each State of the Federation:

Provided that-

- (a) a registered voter shall not sign for more than one independent candidate in respect of the same office; and
- (b) the signatures shall be verified by the relevant electoral body"
- 6. Section 177 of the Principal Act is further altered by-

Alterviou of Section 177

- (a) in subsection (2) (d), by inserting after the last word, "party", the words, "or the person is an independent candidate";
- (b) inserting after paragraph (c), a new paragraph "(cc)" -
- "(cc) in the case of an independent candidate, the person has obtained the verified signatures of at least twenty per cent of registered voters from each of the local government areas in the State:

Provided that-

- (a) a registered voter shall not sign for more than one independent candidate in respect of the same office; and
- (b) the signatures shall be verified by the relevant electoral body"
- 7. Section 228 of the Principal Act is altered by inserting after paragraph (c), a new paragraph "(cc)"-

Alteration of Section 228

"(cc) for the conferment on the Commission of power by regulations to prescribe the payment of such administrative fees by independent candidates for respective elections:

- Provided that the Independent National Electoral Commission shall waive fifty percent of the administrative fees for women candidates."

EXPLANATORY MEMORANDUM

This Bill seeks to alter the provisions of the Constitution of the Federal Republic of Nigeria, 1999 to allow an independent candidate contest for an elective position.
