{ } Commencement.

ENACTED by the National Assembly of the Federal Republic of Nigeria as follows-

1. The Orthopaedic Hospitals Management Board Act, Cap. 010, LFN 2004 (in this Bill referred to as "the Principal Act") is amended as set out in this Bill. Amendment of the Orthopaedic Hospitals Management Board Act, Cap. 010, LFN, 2004.
2. The Principal Act is amended in the Second Schedule by inserting immediately after the existing number "3", a new number "4" as follows –


" The Orthopaedic Hospital, Dekina, Kogi State". Amendment of the Second Schedule.
3. The Principal Act is amended in the Third Schedule by inserting immediately after the existing number 3, a new number 4 as follows:

" The Orthopaedic Hospital, Dekina Prince Abubakar Audu University Teaching Hospital, Anyigba". Amendment of the Third Schedule.
4. This Bill may be cited as the Orthopaedic Hospitals Management Board (Amendment) Bill, 2021. Citation


EXPLANATORY MEMORANDUM

This Bill seeks to amend the Orthopaedic Hospitals Management Board Act Cap. 010 Laws of the Federation of Nigeria, 2004 to provide for the establishment of the Orthopaedic Hospital Dekina, Kogi State under the control of the Orthopaedic Hospitals Management Board and affiliated to the Prince Abubakar Audu University Teaching Hospital, Anyigba, to provide specialized Orthopaedic treatment and medical services.
