AN ACT TO AUTHORIZE THE ISSUE FROM THE CONSOLIDATED REVENUE FUND OF THE FEDERATION THE TOTAL SUM OF ₦13,082,420,568,233 (THIRTEEN TRILLION, EIGHTY-TWO BILLION, FOUR HUNDRED AND TWENTY MILLION, FIVE HUNDRED AND SIXTY-EIGHT THOUSAND, TWO HUNDRED AND THIRTY-THREE NAIRA) ONLY, OF WHICH ₦484,488,471,273 (FOUR HUNDRED AND EIGHTY - FOUR BILLION, FOUR HUNDRED AND EIGHTY- EIGHT MILLION, FOUR HUNDRED AND SEVENTY-ONE THOUSAND, TWO HUNDRED AND SEVENTY-THREE NAIRA) ONLY IS FOR STATUTORY TRANSFERS, ₦3,344,380,000,000 (THREE TRILLION, THREE HUNDRED AND FORTY-FOUR BILLION, THREE HUNDRED AND EIGHTY MILLION NAIRA) ONLY IS FOR DEBT SERVICE, ₦5,649,872,137,888 (FIVE TRILLION, SIX HUNDRED AND FORTY-NINE BILLION, EIGHT-HUNDRED AND SEVENTY-TWO MILLION, ONE HUNDRED AND THIRTY-SEVEN THOUSAND, EIGHT HUNDRED AND EIGHTY-EIGHT NAIRA) ONLY IS FOR RECURRENT (NON-DEBT) EXPENDITURE WHILE THE SUM OF ₦3,603,679,959,070 (THREE TRILLION, SIX HUNDRED AND THREE BILLION, SIX HUNDRED AND SEVENTY-NINE MILLION, NINE HUNDRED AND FIFTY-NINE THOUSAND, SEVENTY NAIRA) ONLY IS FOR CONTRIBUTION TO THE DEVELOPMENT FUND FOR CAPITAL EXPENDITURE FOR THE YEAR ENDING ON THE 31ST DAY OF DECEMBER, 2021

BE IT ENACTED by the National Assembly of the Federal Republic of Nigeria as follows-

- 1 1.-(I) The Accountant-General of the Federation shall, when
- 2 authorised to do so by Warrants signed by the Minister charged with
- 3 responsibility for finance, pay out of the Consolidated Revenue Fund of the
- 4 Federation during the year ending on the 31st day of December 2021, the

1 sums specified by the warrants, not exceeding in the aggregate
 2 =N=13,082,420,568,233 (Thirteen Trillion, Eighty-Two Billion, Four

 4 Hundred and Thirty-Three Naira) only, for the year ending on the 31st day of
 5 December, 2021.

6 (ii) The amount mentioned in subsection (1) of this section shall be
 7 appropriated to heads of expenditure as indicated in the Schedule to this Act.

8 (iii) No part of the amount aforesaid shall be released from the
 9 Consolidated Revenue Fund of the Federation after the end of the year
 10 mentioned in subsection (1) of this section.

11 2. All amounts appropriated under this Act shall be released from the
 12 Consolidated Revenue Fund of the Federation only for the purpose specified in
 13 the Schedule to this Act.

Virement

14 3. In the event that the implementation of any of the projects intended
 15 to be undertaken under this Act cannot be completed without virement, such
 16 virement shall only be effected with the prior approval of the National
 17 Assembly.

Interpretation

18 4. For the purposes of this Act the term "schedule" includes the
 19 detailed estimates of expenditure attached thereto

Short title

20 5. This Bill may be cited as the Appropriation Bill, 2021.

This Bill seeks to authorize the issue from the Consolidated Revenue Fund of the Federation the total sum of =N=13,082,420,568,233 (Thirteen Trillion, Eighty-Two Billion, Four Hundred and Twenty Million, Five Hundred and Sixty-Eight Thousand, Two Hundred and Thirty-Three Naira) only, of which =N=484,488,471,273 (Four Hundred and Eighty - Four Billion, Four Hundred and Eighty-Eight Million, Four Hundred and Seventy-One Thousand, Two Hundred and Seventy-Three Naira) only is for Statutory Transfers, =N=3,344,380,000,000 (Three Trillion, Three Hundred and Forty-Four Billion, Three Hundred and Eighty Million Naira) only is for Debt Service, =N=5,649,872,137,888 (Five Trillion, Six Hundred and Forty-Nine Billion, Eight-Hundred and Seventy-Two Million, One Hundred and Thirty-Seven Thousand, Eight Hundred and Eighty-Eight Naira) only is for Recurrent (Non-Debt) Expenditure while the sum of =N=3,603,679,959,070 (Three Trillion, Six Hundred and Three Billion, Six Hundred and Seventy-Nine Million, Nine Hundred and Fifty-Nine Thousand, Seventy Naira) only is for contribution to the Development Fund for Capital Expenditure for the year ending on the 31st day of December, 2021
